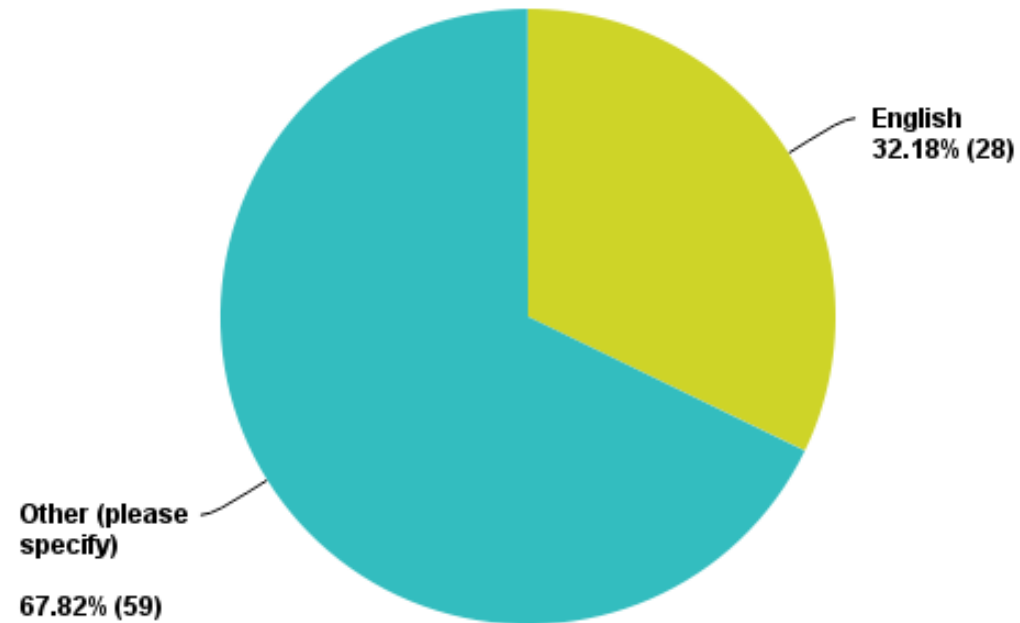

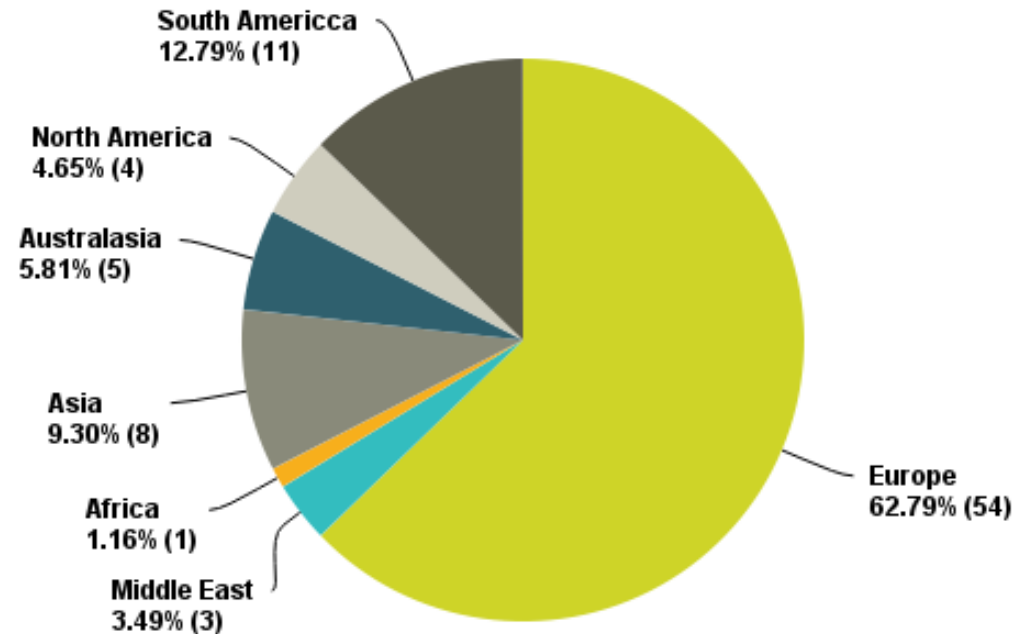

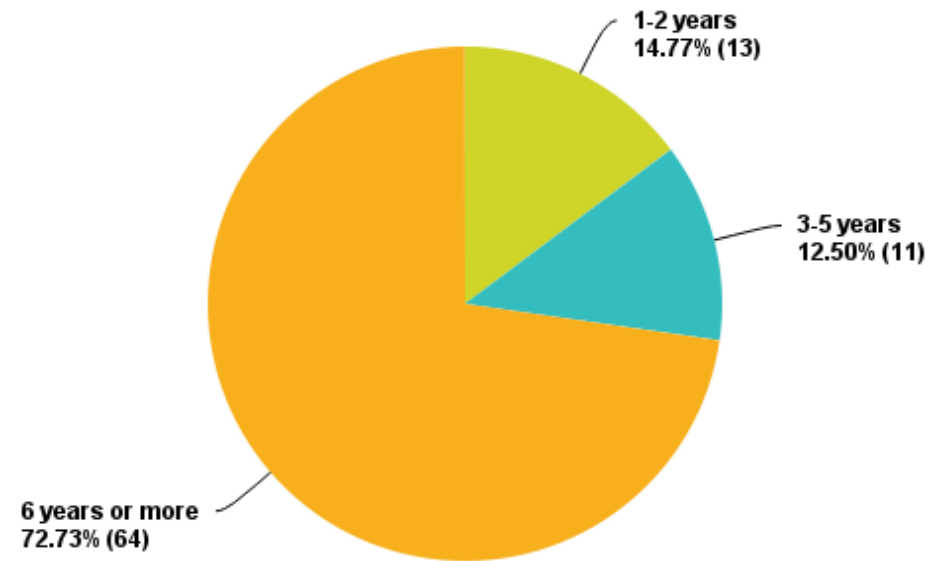

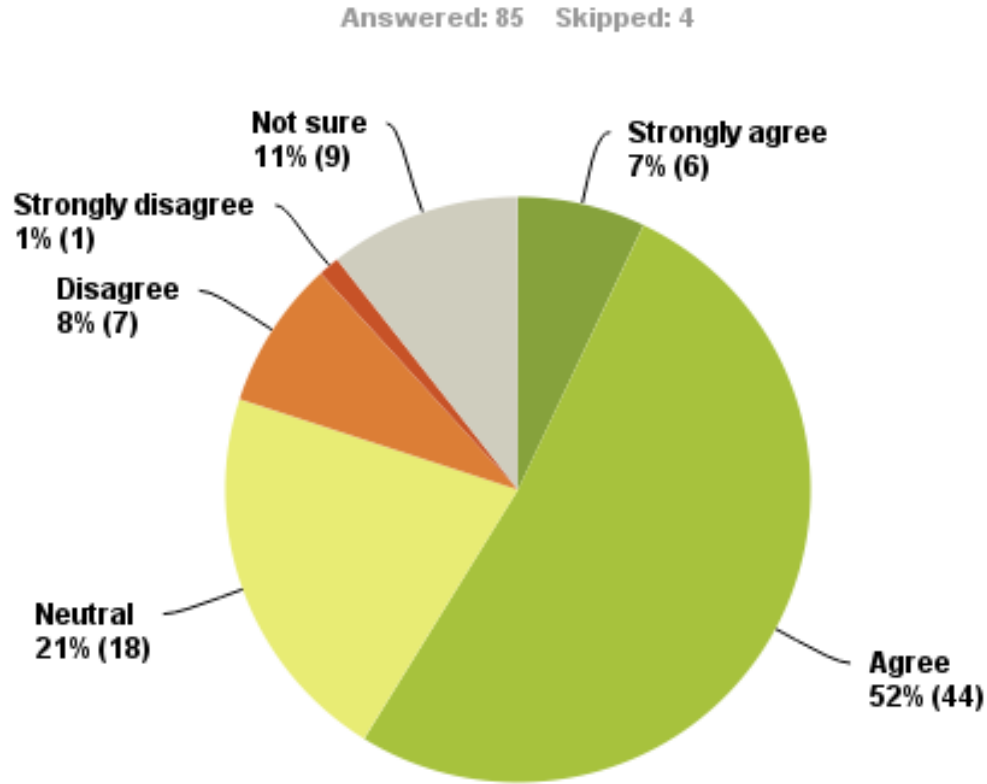

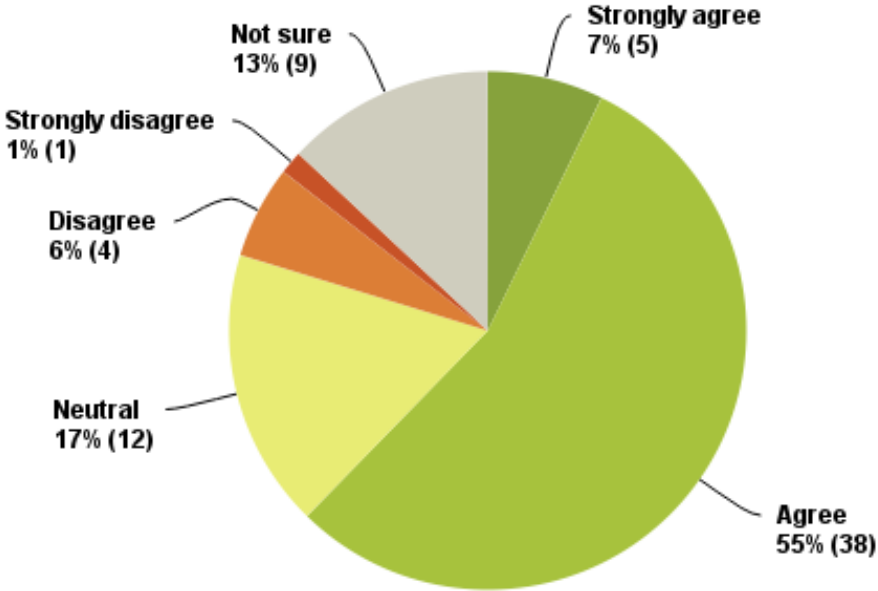
Pilots' and ATCOs' plain language proficiency has improved since the ICAO LPRs were introduced.



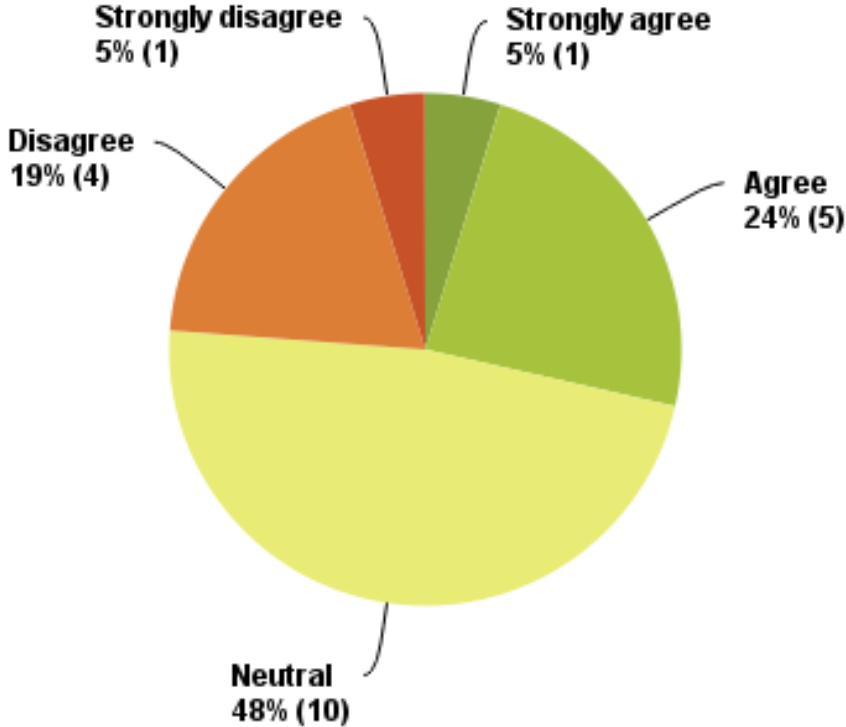

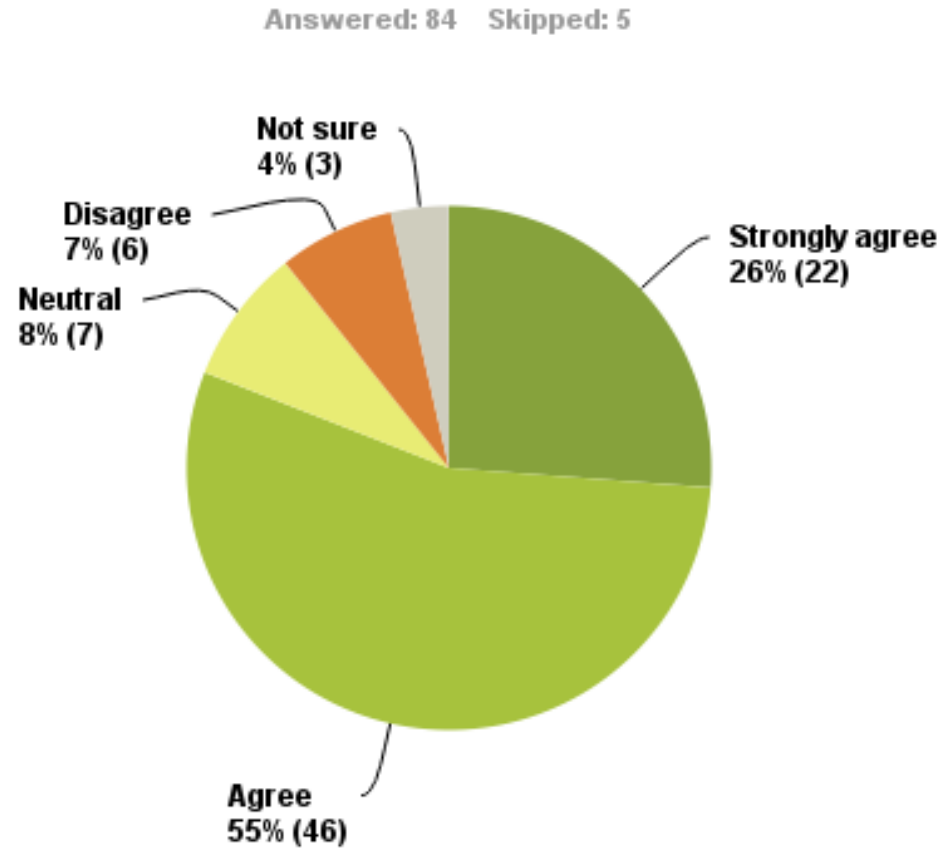

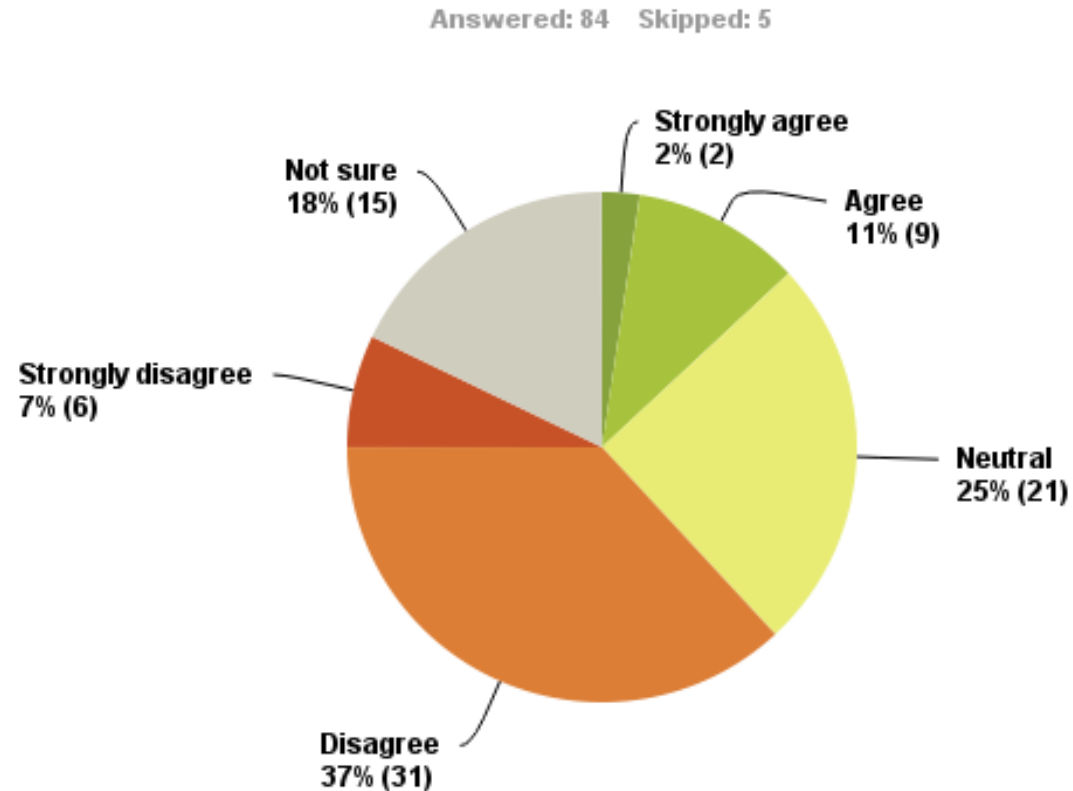
Non operational participants vs pilot and ATCOs views



The introduction of the ICAO LPRs has led to a greater awareness of the importance of the role of English language proficiency in air ground communications.

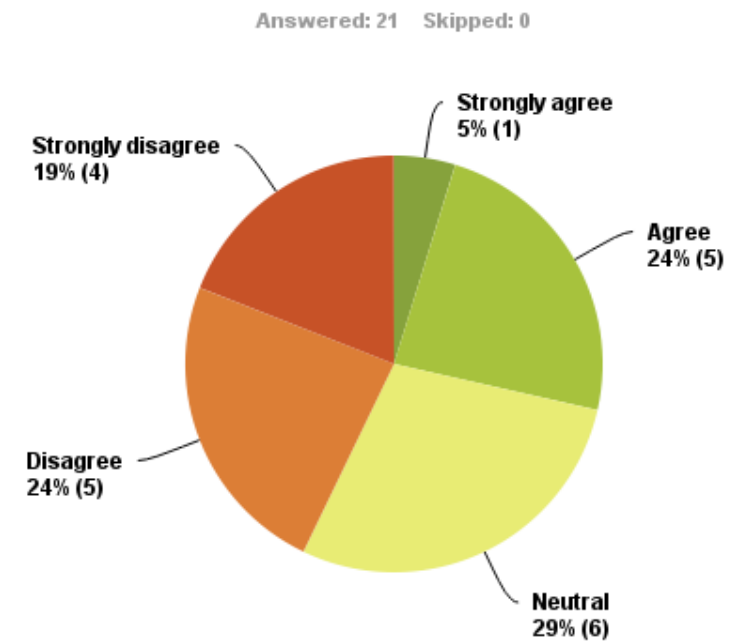
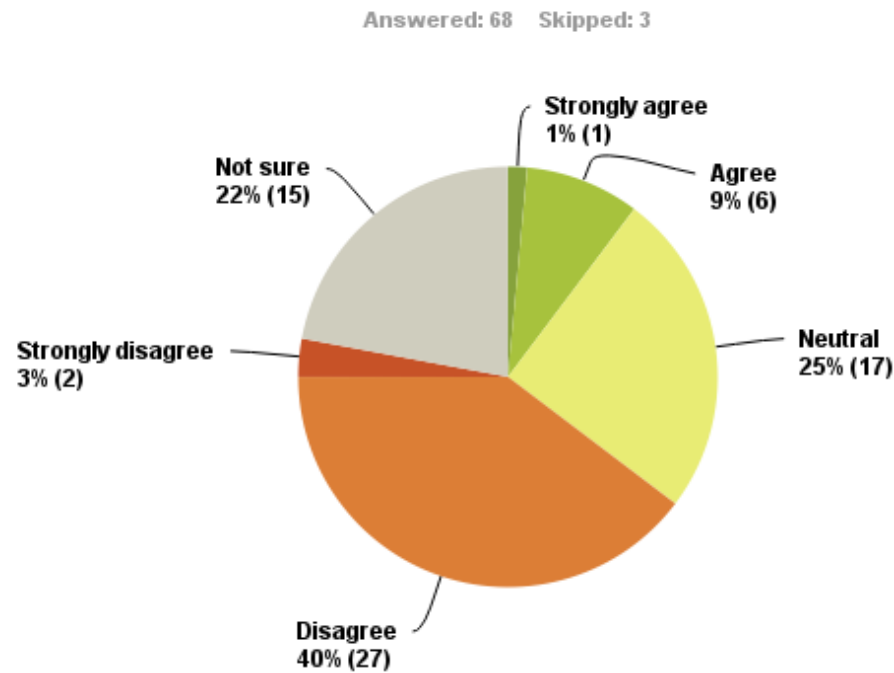

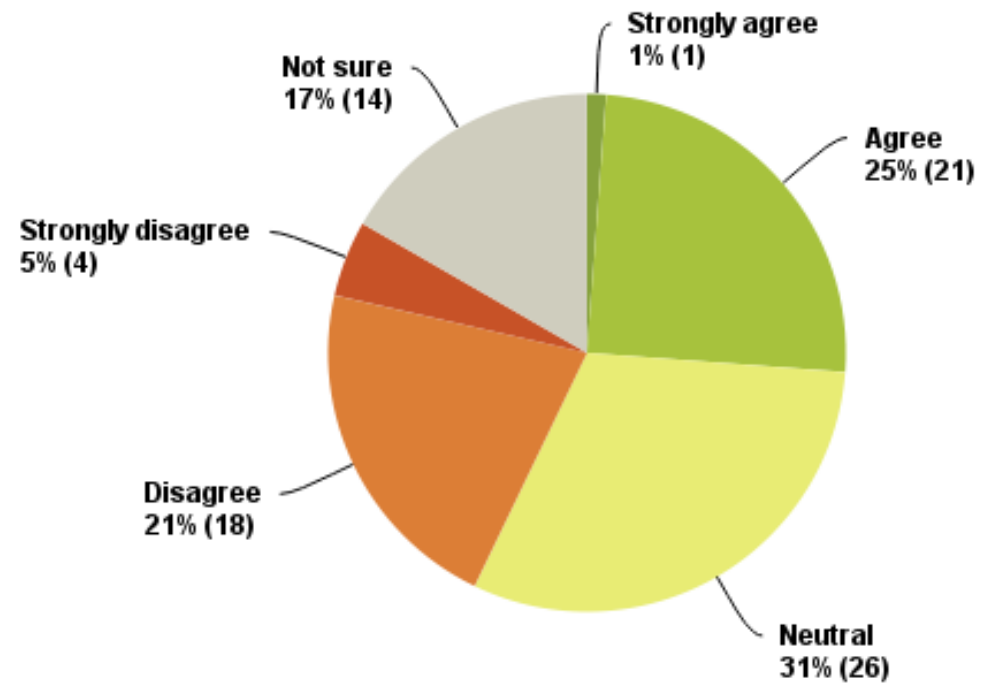

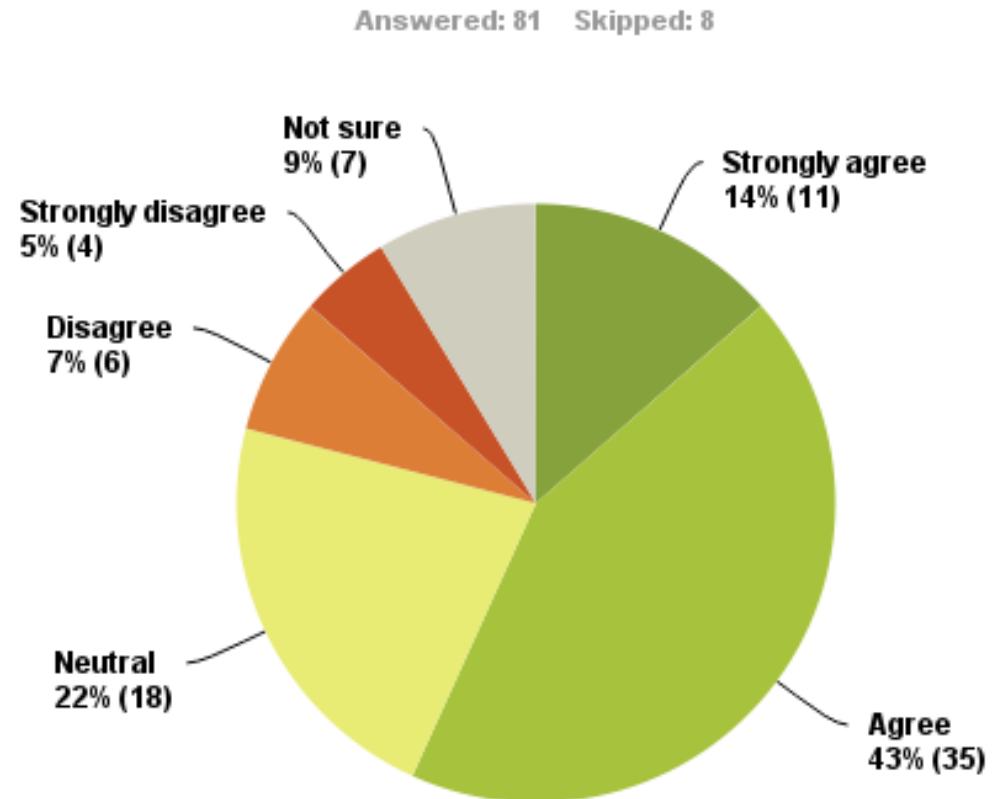

Non native English speaking pilots and ATCOs vs Native English speaking pilots and ATCOs

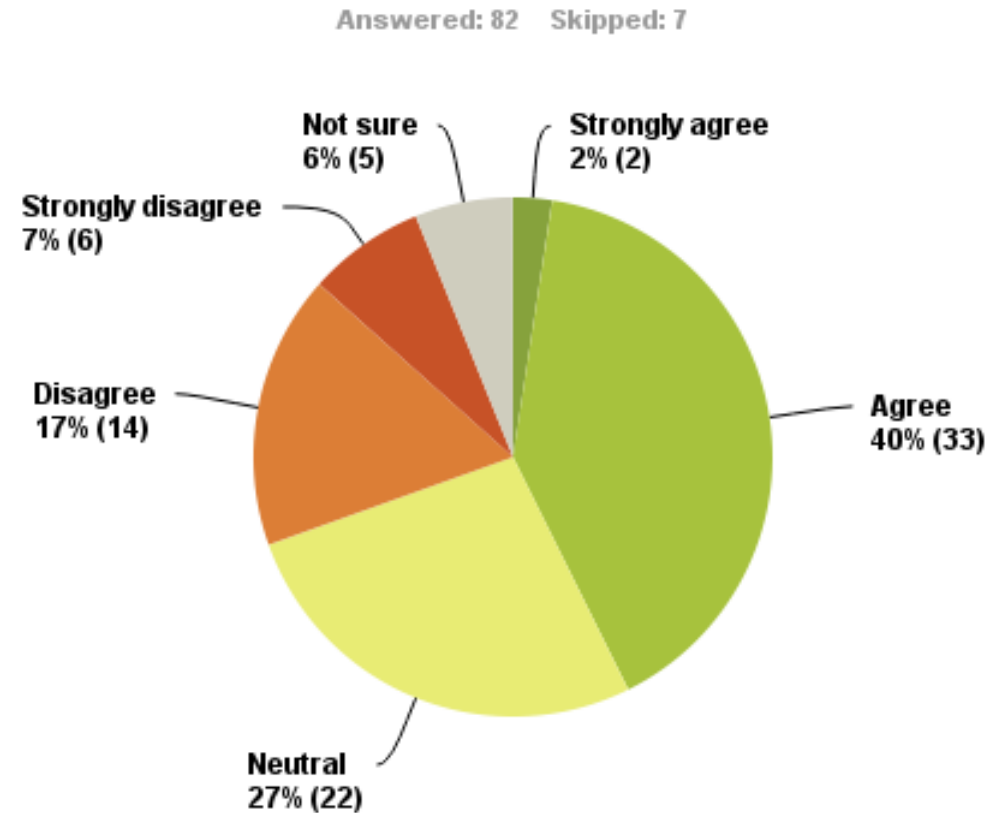

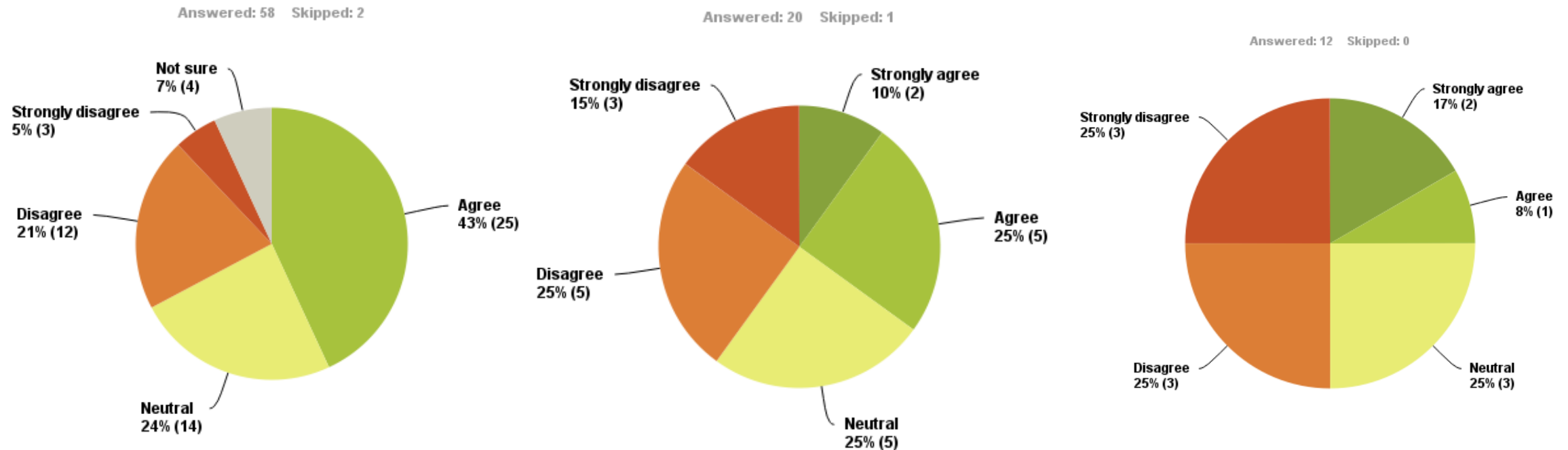

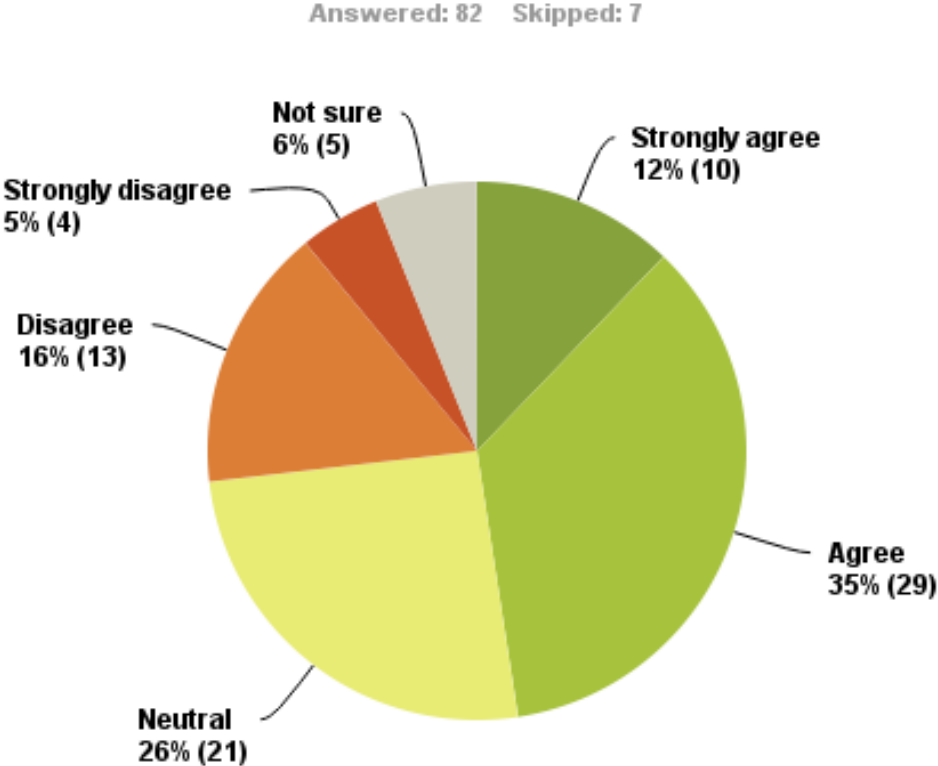


Test adequately assess comm'n needs

- 50% non-native Eng Sp pilots/ATCOs

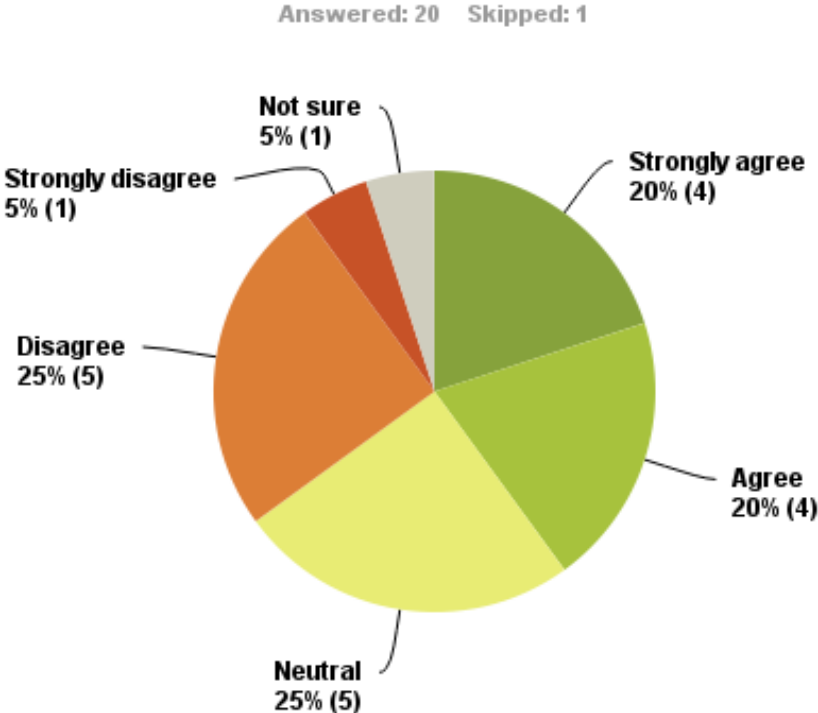
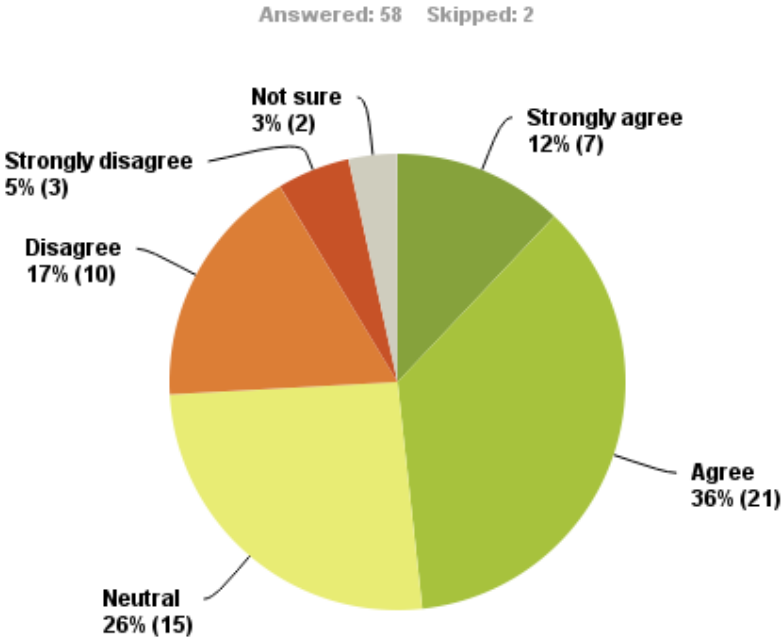

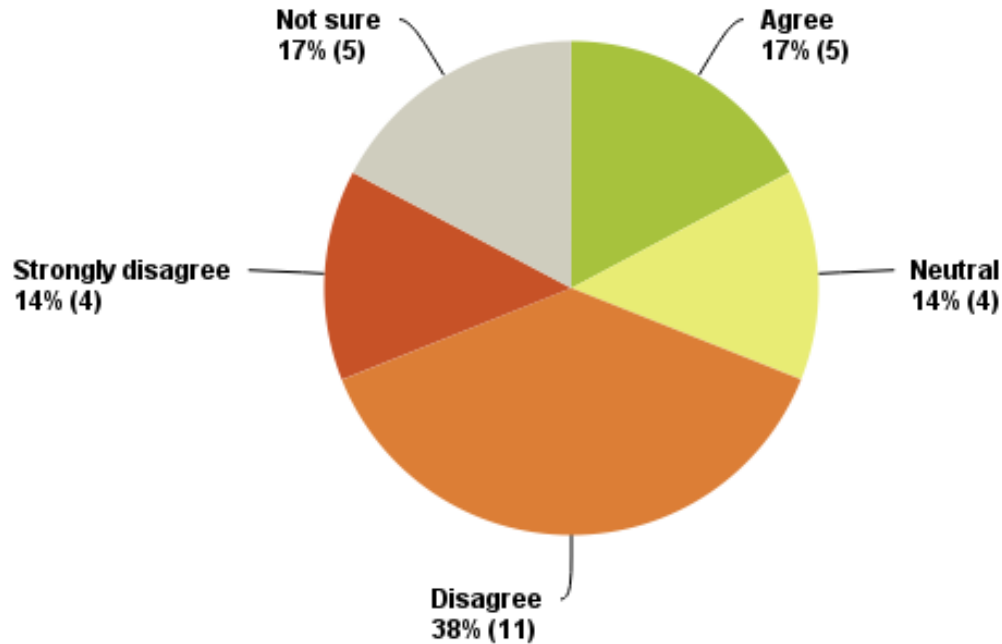

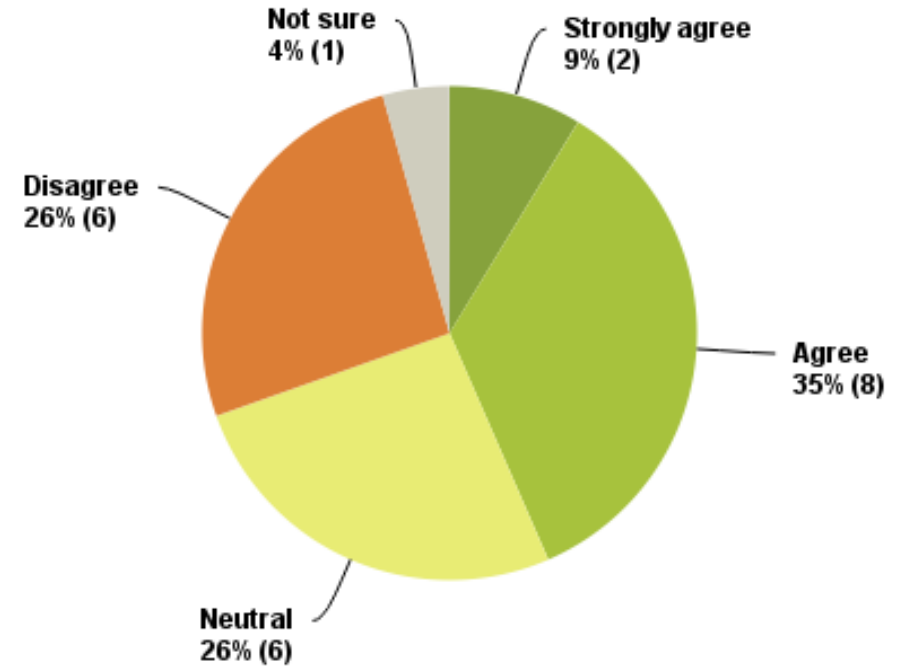

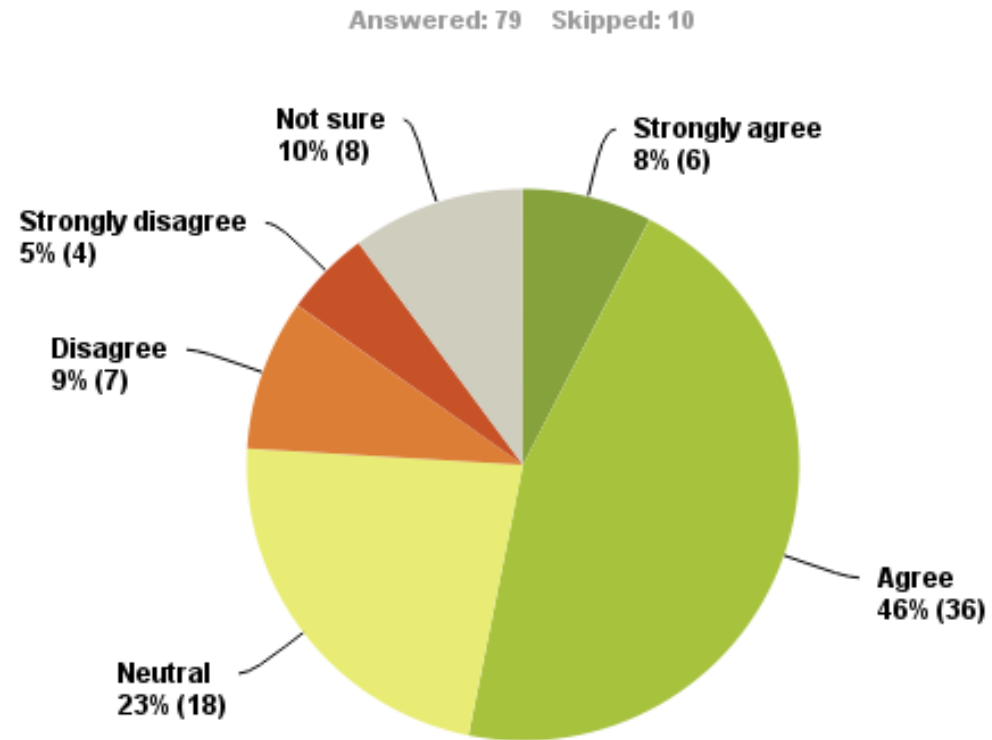


Sufficient training between tests

- States 1 ATCO test v states 2+ tests 44% v 17% agree



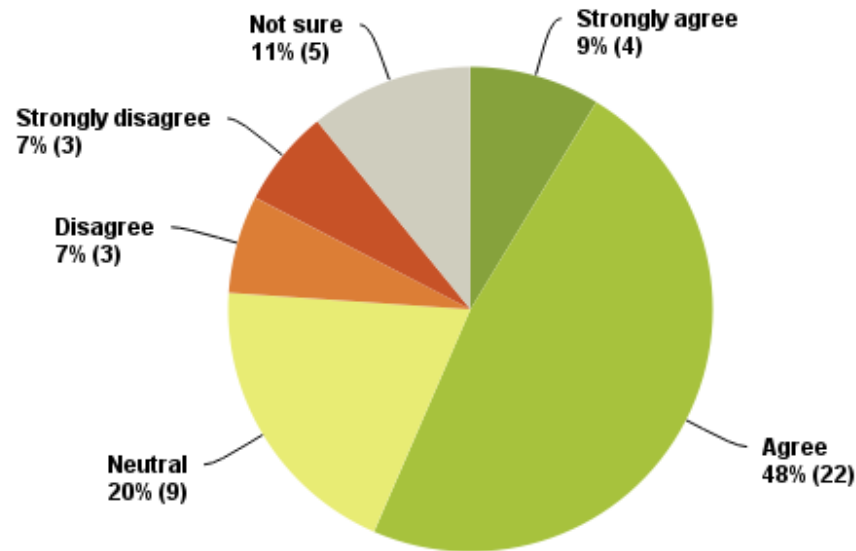

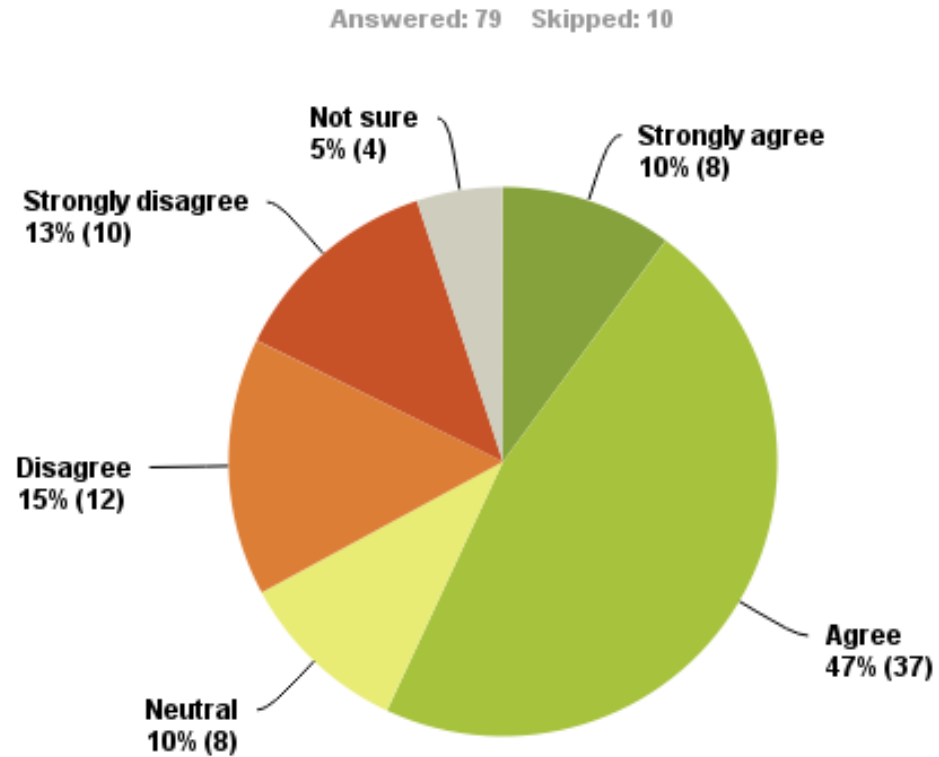

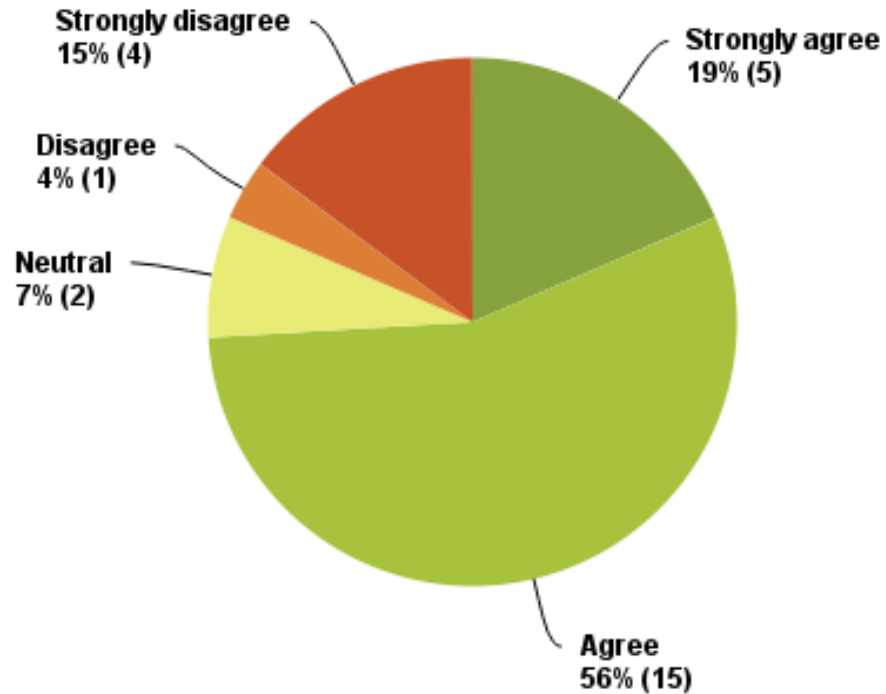

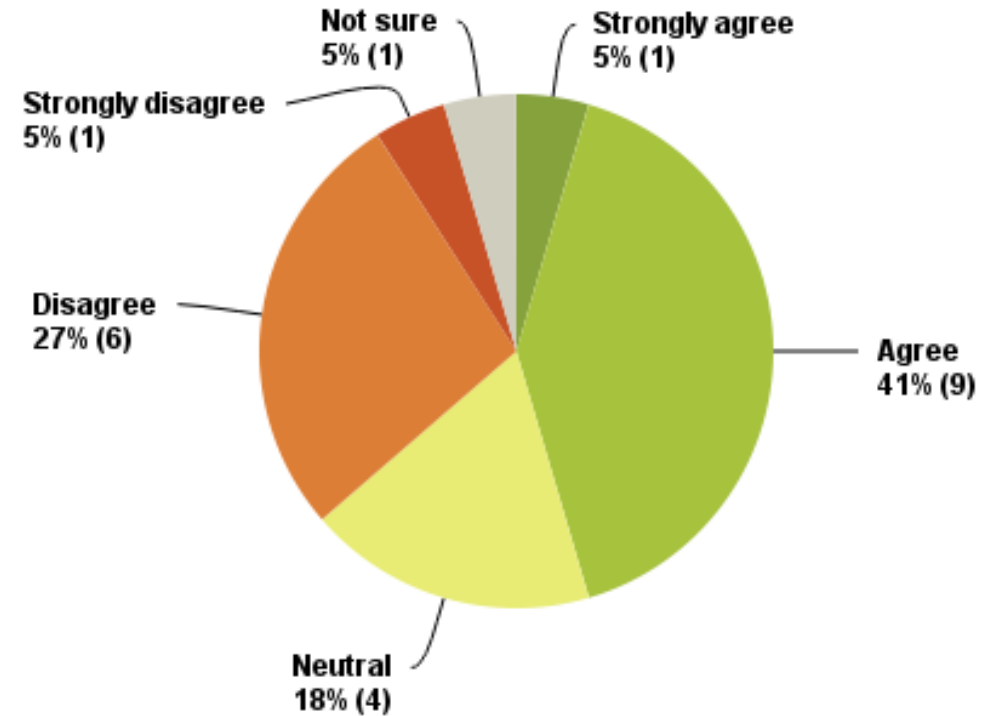

Regulators vs Testers vs Pilots and ATCOs

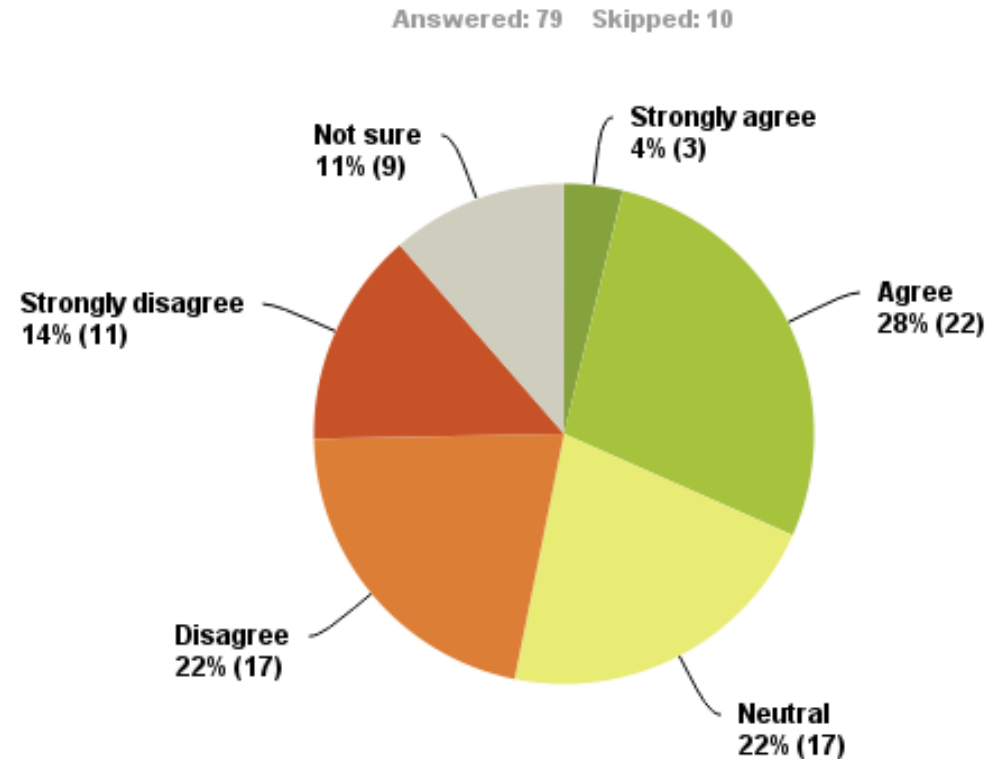


Sufficient monitoring standards

- Pilots and ATCOs 23% agree / 50% disagree

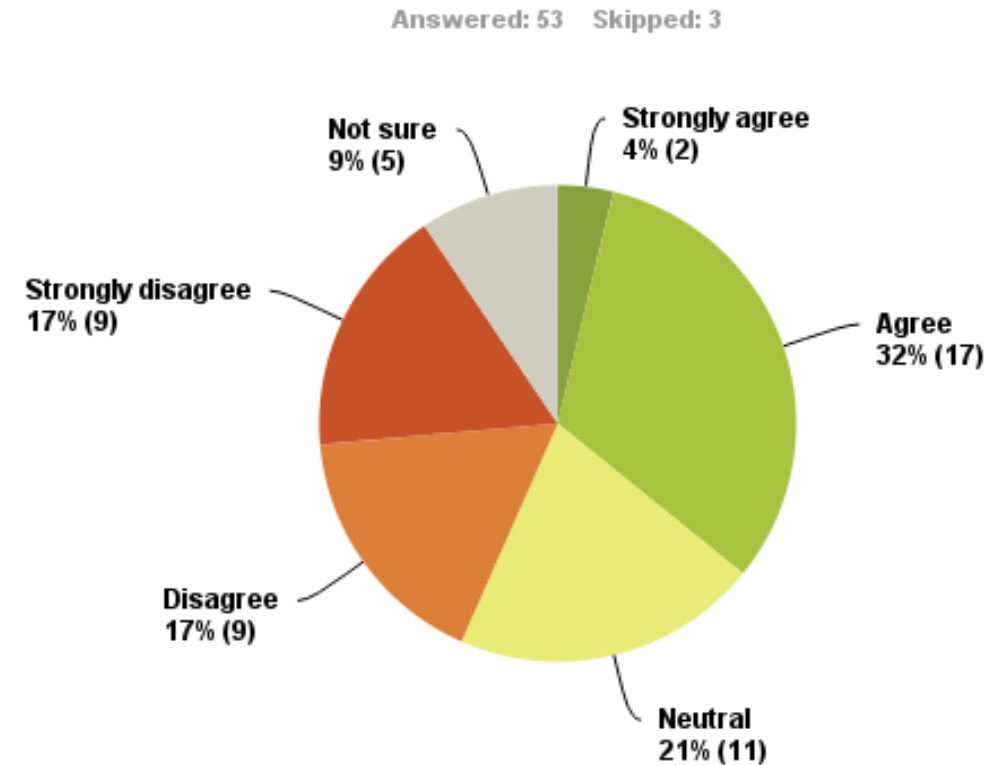
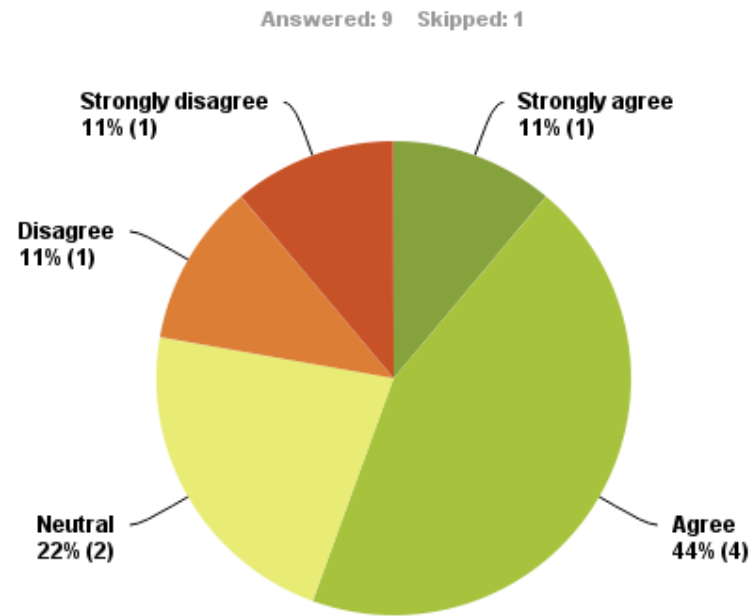

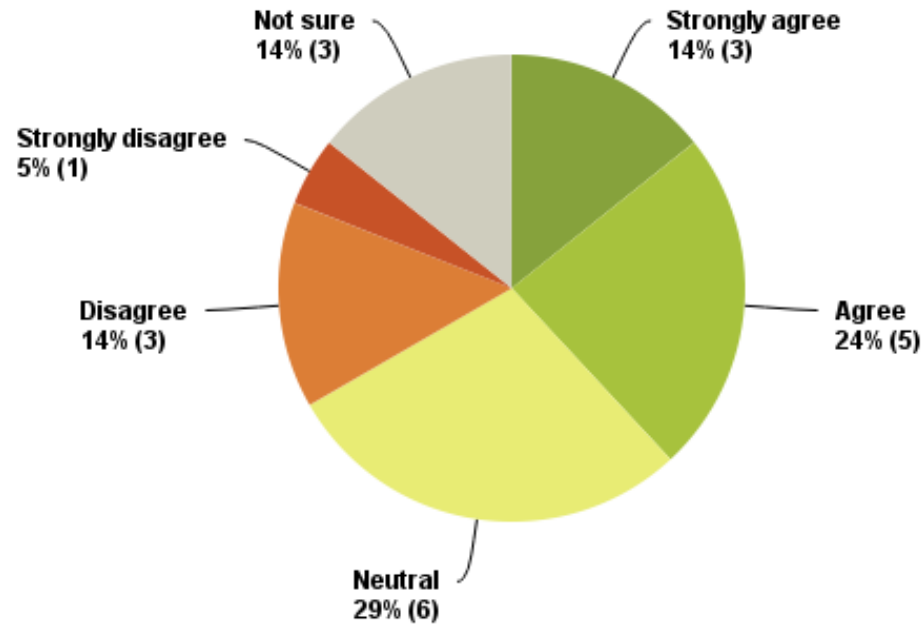

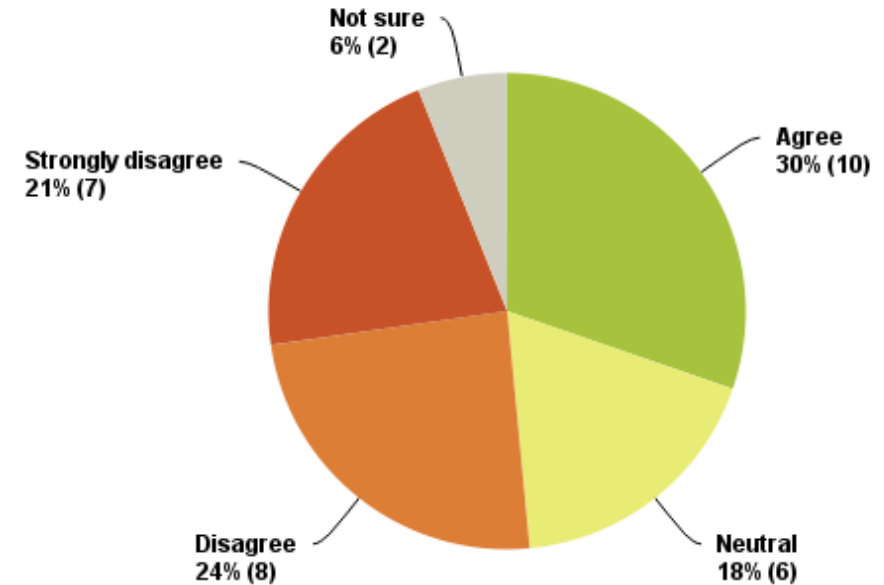

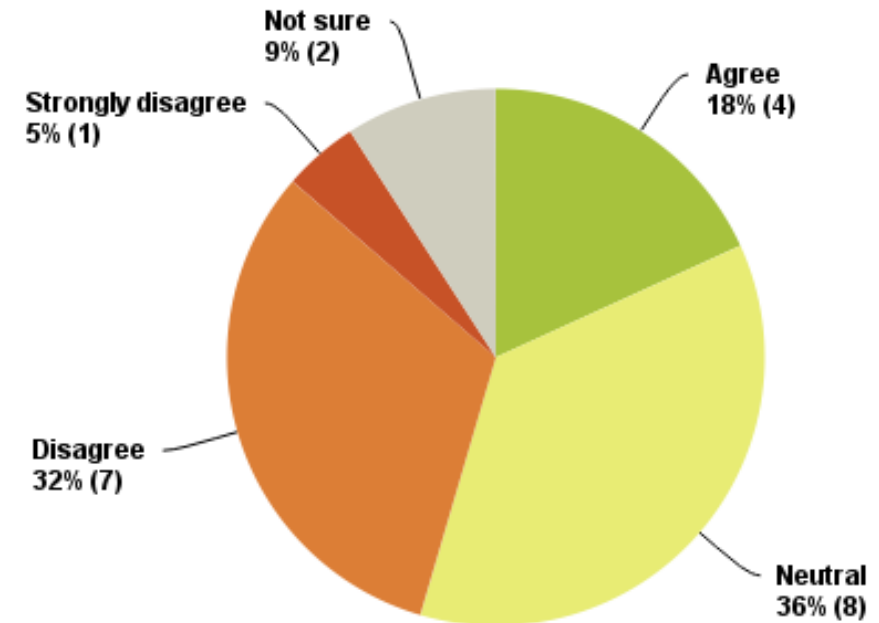
