

Environmental Impacts

- Transportation accounted for the largest portion (29%) of total U.S. greenhouse gas (GHG) emissions in 2019
- The vehicles we drive account for 82% of those emissions
 - Light-duty vehicles = 58%
 - Medium- and heavy-duty trucks = 24%

Environmental Impacts

- GHGs are emitted from the tailpipes of cars and trucks that once released, are here for 100+ years
- GHGs "act like a blanket around Earth," changing our climate, raising sea levels, and impacting our future
- So what?
 - Nitrogen oxide, non-methane organic gases, carbon monoxide, particulate matter, and formaldehyde are also emitted = SMOG TODAY









Financial Impacts

- In 2020, households spent an average of \$9,826 on transportation
- We spend more on transportation than food, education, or healthcare
- Most of that transportation budget goes toward purchasing, operating, and maintaining private vehicles

How Much Does it Really Cost to Own a New Car?


Buying a car is one of the biggest purchases a person will make in their lives. Before embarking on the car buying journey, it's important to understand how much it will cost beyond the sticker price. Since 1950, AAA has published its annual Your Driving Costs study that looks at the most popular models on the market and breaks down the cost of owning a new car including depreciation, finance, fuel, insurance, license/registration/taxes and maintenance/repair/tires.

The overall average cost to own and operate a new car in 2021 is \$9,666.

Health Impacts

- Obesity-related conditions include heart disease, stroke, type 2 diabetes, and even cancer
- Adults should get 150 minutes of moderate physical activity each week (30 minutes a day, 5 days a week)
- Transit riders "spend a median of 19 minutes daily walking to and from transit"












- Record your trips to unlock access to the Reimbursable Rides reward
- If the unexpected arises, we've got you covered
 - You must arrange your own transportation to or from work (taxi, Lyft, Uber, or a coworker/friend)
 - Submit your receipt and provide info for your trip
- We will pay you back for the cost of the ride
 - Up to six times a year, up to \$600 total
