Female student molested in Village

Safety also finds ammunition in Adams room after unrelated incident

Residents of the Student Village are on edge after a female student living in O'Connor Hall was molested in her room. According to the Daytona Beach Police Department, the O'Connor victim (whose name The Avion is withholding) awoke in

her second-floor room at approximately 1:
30 a.m. on the morning of Jan. 28 to find Blake Bosworth, a Safety Science junior Blake Bosworth Science junior Bl who lives on the fifth floor of O'Connor, standing over her and groping her breasts, his penis hanging out of his pants.

The victim told police that Bosworth's body language indicated he wanted to have intercourse with her, but he did not speak while he was in her room.

Bosworth did not leave, even after she repeatedly told him to, and tried to get in bed with her. When his hand traveled from her breasts to her panties, she quickly got out of bed and fled to another room in the suite. Bosworth made no attempt to stop her; in fact, she later told police she was struck by his "seemingly calm, serene, measured actions."

After at least two minutes passed,

and gave chase, but Bosworth had

already left the hall. They then placed a 911 call, and a description of Bosworth was relayed to Embry-Riddle Campus Safety. At about 2 a.m., Campus Safety officer Thomas Botelho observed Bosworth, still with his pants unzipped, on the stairway between the third and fourth floors

of O'Connor Hall. Bothelho reported that Bosworth seemed lethargic, and Bosworth, 20, admitted that he had been drinking at the Rolex 24 race, which was being held that weekend.

Bosworth was identified by the victim

a report came in from the third

floor of Adams Hall.

That report said a man similar in appearance to Bosworth had entered the room of two females while they were sleeping and began to disturb their belongings. The noise woke the two females, who turned on the lights. They delayed in reporting the incident by about half an hour, instead speaking to their friends first. Both victims identified Bosworth as the intruder.

Detectives determined that there was "insufficient probable cause" to charge

Bosworth with attempted sexual battery He was charged with one count of battery and two counts of burglary. All are

Bosworth claimed he entered the rooms while he was looking for his own fifthfloor room. He also admitted that he entered a third room, but no third set of victims has come forward, according to the police report.

Interviews with the witnesses and victims indicated that in both instances Bosworth gained entry through unlocked

"Lock your doors, no matter what," SGA Chief Justice Andrew Leech said. Leech who sits on Embry-Riddle's Honor Board said that should Bosworth elect to stay at the

A new meaning to 'flying blind'

Pronounced dead on arrival, doctors worked vigilantly to revive the lifeless body airlifted in from a plane crash site. Both engines on the aircraft had failed over a field. The swollen face was unrecognizable. The jaw was broken in four places,

the nose was shattered and the left eye was missing. Coupled with a severely injured head were collapsed lungs and a broken leg. Doctors hesitated to operate, as there was little hope in saving him. Family and loved ones waited in the ICU center of Roanoke Regional Hospital. Sitting on the operating table in a comatose state was 26year-old Barry Hyde.

After a 10-week stay in the hospital, Hyde returned home. Though he had a

Low enrollment numbers leave less money for clubs, divisions

A sharp drop in enrollment numbers has dropped the Student Government Association's funding by more than \$46,000 this semester, an 11.7 percent drop, according to SGA Treasurer Natalie Anaya.

In fall 2006, the SGA fee of \$85 was collected from 4,698 students for a total of \$399,330. By contrast, this semester there

are only 4,150 projected students for a total of \$352,750.

The University was not scheduled to publish its final enrollment numbers until today, a week later than normal due to the Christmas Day tornado.

Anaya and the Student Finance Board used 4,150 as a target number rather than the University's preliminary estimate of 4,469 because students enrolled in online courses only and students on internships and co-ops do not pay the SGA fee.
Although the SGA always experiences a

drop in revenue from fall to spring, this year was far more precipitous than last year. The fall 2005 budget was \$376,040 and fell to \$372,470, a drop of less than one percent.

"Last spring they did not account for co-op students, who do not pay the SGA fee," Anaya said. She also said she used a

Sigma Pi injured in parade recovering well

Brandon Walters, the Sigma Pi associate member who was injured in the homecoming parade on Oct. 27, is back home in Indiana making a good recovery, according

to the fraternity.

Walters, 19, was hospitalized in critical condition with a fractured skull after falling off the trunk of a car. Two other students also fell but were uninjured.

Walters had to undergo surgery to relieve pressure on his brain, and returned to Indiana after coming out of a medically-induced coma several weeks after the accident. With two surgeries to go, Sigma Pi's Patrick Schubert told *The Avion* that Walters

will suffer little to no permanent damage. Schubert passed along the family's gratitude

for all the support they received from the Walters has since been fully inducted into the Sigma Pi fraternity, and Schubert said

that Walters would return in Summer A.

Assistant Director of Student Activities and Greek Life Advisor Aaron Clevenger has been promoted to Director of Student Activities.

Clevenger succeeds Ossie Benitah, who is moving to Seattle after working in Student Activities since 1995.

The selection was made by Dean of Students Sonja Taylor after Benitah announced her resignation last month. Clevenger was informed

of the news late on Friday, Jan. 26, but the formal announcement was delayed until last week.

Clevenger named Director

"She has been an amazing boss to work for," Clevenger said. He has worked under Benitah since February 2004, when he joined the staff of Embry-Riddle.

Since then, in addition to serving as Greek Life Advisor, he has also overseen the Volunteer Network and served as an advisor for The Avion newspaper and as an interim advisor for the Embry-Riddle Resident Student Association.

During his tenure as Greek advi-

sor, Clevenger oversaw the Embry-Riddle installations of the Pi Kappa Alpha chapter in 2004 and the Sigma Sigma Sigma chapter in 2006.

Before the Christmas Day tornado forced Clevenger to concentrate on the campus recovery of Eagles FM and the Avion, Clevenger also served as the chair of the local Relay for Life 2007.

Clevenger holds a bachelor's degree in interpersonal communication and a master's degree in student affairs, both from the University of Central Florida.

With Clevenger taking over

Benitah's position, the search has begun for someone to fill his old position. This is in addition to a continuing search for a new Assistant Director for Housing and Residence Life, which would repre-

"Not everybody gets the opportunity to get promoted in the university where they have already worked," Clevenger said, "so I feel very lucky that Dean Taylor has given me the opportunity to work in a university that I already know."

conservative estimate of students to ensure that the SGA had a "buffer zone" while they budgeted.

The SGA revenue is divided into several categories, including initial expenditures, the three SGA divisions (Touch-N-Go Productions, The Avion and Eagles FM) and club funding.

The club funding took the hardest hit, dropping 51 percent from \$75,284 to \$36,867.75.

The division budgets fell \$19,647.50, or 10.1 percent. Both TNG and The Avion saw decreases, while Eagles FM actually saw an increase as they prepare to open a recording studio.

"We re-evaluated our initial expenditures," Anaya said, in an attempt to find more money for clubs, adding that they freed up \$4,000.

Despite this, initial expenditures rose from \$103,125.85 to \$112,529 because they also have to fund the first half of summer. SGA funds are disbursed in the Summer B term, after the new fiscal year starts. Some item listed as initial expenditures are Safe Ride, salaries for SGA employees, supplies for the SGA coffee machine and the Daytona Beach News-Journal subscription.

Last semester, student abuse of the Safe Ride system caused its cost to balloon to \$31,669 - more than \$11,000 more than was budgeted. After the rampant abuse was discovered, the SGA has imposed restricted hours on the program, and the Student Court is prosecuting some offenders. The coffee machine - a popular spot between classes - set the SGA back \$9,156.

The budget deficit of Safe Ride was covered by monies from the

SGA restricted fund and did not affect the Spring club budgets. The restricted fund is also used for capital expenditures or issues that crop up during summer, when enrollment, and therefore SGA revenue, is at its

The Executive Budget, which is not a division but listed under the same heading for budgetary purposes, stayed steady at \$28,100. The Executive Budget covers the operating expenses of the SGA.

The SGA sets aside three percent of its revenue to an unallocated fund for use in case of emergencies. If no emergencies present themselves, the unallocated fund is opened for club and organization requests half way through the semester. This semester, the date is March 1 and the fund contains \$9,983.

Anaya has also arranged for half the money that was allocated last semester but never claimed to be placed into the spring budget. The other half is being placed into the restricted fund, each segment totaling about \$13,000.

Anaya acknowledged that funding for clubs was tighter this semester, but also offered several options for clubs who need more money. Clubs can always appeal their budgets to the SFB, or can perform more fundraisers.

"I usually direct them to the Annual Fund," Anaya said. "A lot of clubs and organizations don't realize how many fundraisers they can do."

She also stressed that students could always talk directly to her.

"My door is always open. If I'm not here, send me an e-mail," she said. "If I can't help you out, I'll point you in the right direction."

University he would have to appear before the Honor Board.

"Always lock your doors," Campus Safety's Bob Upperman said. "Even when you're in your room, lock your door ... The biggest way to prevent crime is to lock your doors. That way you're depriving the unscrupulous person of opportunity."

In an unrelated incident, Campus Safety searched a second-floor Adams Hall room after its resident threatened another student, saying he had a gun. Although they did not find a gun, they did find ammunition for a gun, which is still in violation of the housing guidelines.

"We got some ammunition out of there," Upperman said. "They need to abide by housing regulations. You can't have weapons of any type, or their ammunition."

Upperman also added that the weapons policy also applies to weapons that do not require ammunition, such as knives.

be there," Village resident Dustin Crooks said, adding that he knows the student involved.

"But if you find the shells, the gun is probably somewhere," he added.

In response to the incidents. Campus Safety said the Student Crime Prevention Practitioners have increased their patrols through the residence halls, and are possibly issuing an Eagle Alert this week Last week, the Safety Department sent an e-mail alert to all females living on-campus encouraging them to take precautions, but did not cite

any specific instances. Residents say that Housing has not informed them of the events.

Two years after the accident, Hyde was introduced to a godsend. He spent 26 days in training with his assigned dog, walking through revolving doors, up and down escalators, and crossing streets. Lincoln, a black Labrador, serves not only as his eyes, but also his companion. Hyde, with a hand on Lincoln's head and a smile on his face explained, "Lincoln is the smartest, greatest dog I have ever been around. He is the inspiration that has allowed me to carry on and the greatest set of eyes I will ever Lincoln is worth 40,000 dollars, but I wouldn't take all the money in the world for him. I love

His educational goals were always a priority. Preceding the accident, he had received his private pilot's license and associate's degree in Business Administration. Following the accident, he completed his bachelor's degree in History, while pursing his passion: aviation. In 2000, Hyde became the first blind person to receive his advanced ground instructor and instrument ground instructor's

"The FAA didn't know what to do

with me. The examiner had never given an oral test for these certifications. I passed and he said I did better than he did. It's funny though, the examiner received a certification of achievement for it, and all I got was a license," he explained

Hyde has had Embry-Riddle in his future plans for years. With his passion for aviation, ERAU was the place for him to continue his master's in Aviation Science and Aeronautics. He moved to the area in August of 2005 and began

"It has been a dream come true, I never thought I would be able to continue with my aviation career. It has been an awesome experience."

Hyde has maintained a 4.0 GPA with plans to teach part time in the flight labs on campus. While teaching new pilots, he wishes pursue his doctorate.

"I didn't think it was possible, but I'm here and I'm doing it. I know God has a purpose for me.'

Hyde sits in the crowded University Center with other students and faculty. Lincoln wags his tale under the table as he enjoys his lunch. A friendly, lively dog, Lincoln sets his head on welcoming laps. Barry is told what is on his

plate by clock positions. The time is told to him by holding a button on his watch. He talks with a smile and has jokes on hand. When asked about the cold weather, he explained that he enjoys the Florida sunshine; the cold weather is difficult due to the metal plates throughout his body. Despite all of the medical trauma and challenges he has faced, Hyde has a wonderful outlook on

life and is an amazing individual.

Eight years, eight months and five days ago, Hyde was pronounced dead; he recalls the date to this accuracy. Six years ago, he became the first blind person to receive his advanced ground instructor's license and instrument ground instructor's license. Today, he continues to follow his dream living life to the fullest.

Dr. Ray speaks on industry learning

Dr. Sally Ray was the keynote speaker for the Communication Industrial Advisory Meetings that occurred last week. She is the author of "Strategic Communication in Crisis management: Lessons from the Airline Industry," as well as the communication department chair at Western Kentucky University in Bowling

Ray is highly regarded within the communication field, and holds a Ph.D. in Organizational Communication from Wayne State University as well as a M.A. in Speech Communications and a

B.A. in English. Ray's keynote address on Thursday night focused on organizational learning and seeing how the aviation industry learns, or not

learn, from crisis situations. She defined a crisis as something that "focuses attention on one particular concern (i.e. Human error, lost lives, etc.), calls for

capabilities and concern for people affected and for the interests of the constituencies involved."

Dr. Ray gave many examples of how airline crashes have become teaching tools for how to be respond to and deal with crises; but even more so, it shows just how many people and companies across various industries are effected.
"In the case of an air carrier

crash, not only is the airline jolted, but it effects resonate to other airlines, the aircraft manufacturer, the engine manufacturer, the FAA, other industry groups, and the public at large" said Ray.

She talked about how crises can inevitably be broken down into three phases: the pre-crisis, crisis and post-crisis. Pre-crisis is the norm when risk is at an acceptable level and that all safeguards are in place. Crisis is the time of turmoil, when the damage occurs. Post-crisis is the investigation period and when organizational learning occurs.

Things are learned every time a crisis occurs, whether it's an airline and learn from them.

cooperation, and gives an organi- crash, a shuttle explosion, a scandal, zation a chance to demonstrate its an assassination or any other event that could be considered a crisis. Organizational Learning is simply taking those things and being able to learn and change things to insure that the crisis is never repeated.

Sometimes in the aviation industry lessons are not learned and crisis repeats itself as it did in Lexington, Ky. in August 2006. This crash of Comair flight 5191 is an example of "failure to learn from failure."

Many accidents have occurred over the years due to pilots taking off from the wrong runway, yet Comair didn't learn from the past failures of other airlines and had no written procedures specific to runway identification before take off.

Lastly, Dr. Ray said that, within the industry, organizations must take into consideration the results from their failures and learn from them. Communication is required from the most affected to the most unaffected divisions of a company, and that companies can only learn and grow from their mistakes if they are willing to see the problems



Basketball's losing streak extends to 4

BEACH, Orlando native and Boone High School product Preston Adams came out a little cold as is expected at times in your freshman season, but the rookie quickly heated up in the second half and virtually took control of the game scoring 22 points to lead Florida Sun Conference first-place Warner Southern College (16-7 overall and 6-1 in the FSC) to a 58-57 road victory against Embry-Riddle University Tuesday night.

Adams, who was 0-for-4 in the first half (0-for-2 beyond the three-point arc), was 9-for-10 in the second half with four three-pointers. ERAU (19-6 overall, 4-3 in the FSC) pushed the lead to 13 early in the second half and Adams kept the Royals in the game hitting back-to-back threes keeping it a 10-point game. Denver Cobb gave Embry-Riddle a 43-30 lead on his three-point at the 15:12 mark of the game, but Adams countered with a jumper and Maurice Johnson followed with a three-pointer to cut the advantage to single-digits at 43-35. The Royals were potent from beyond the arc in the second half converting 66.7 percent from downtown (6-of-9 and four from Adams).

The Eagles regained a 10-point

lead on Tyler DeBord's layup 10: 02 left, but Adams was relentless on the offensive end of the floor canning two more long-range buckets to trim the margin to 48-44 with 7: 59 remaining. Following a Houston Wright layup, Adams took over once again with a jumper and after an Eagle miss he came back with a driving layup to make it a two-point game 50-48 with just over seven min-

Alex Castillo tied the game with a jumper at the 4:50 mark and Drew Whitaker gave the Eagles a 51-50 lead splitting a pair of free throws. Johnson made 1-of-2 from the charity stripe to tie the game at 51 and then current FSC Player of the Week Brandon Hamilton sank a threepointer with 1:43 left to give Warner Southern a 54-51 lead - their first lead since 12-11 at the 11:48 mark of the first half

DeBord brought it back to a onepoint game with a layup with 1:17 to go, but Adams converted another layin to push it to 56-53 Royals. Cobb got loose around the tight pressure by WSC guarding against the three and made it a 56-55 ballgame with 49 ticks left. Safety tips while abroad

U.S. Department of State

As the time approaches for spring or summer break, many college students are getting ready for a much anticipated trip abroad. The following information is geared to help students plan a safe and enjoyable adventure.

First, a note about passports: effective January 2007, all persons - including U.S. citizens - traveling by air from Canada, Mexico, the Caribbean, and Bermuda, will be required to have a passport to enter the United States. This is true even if the foreign country visited does not require a passport for entry. Students who have previously traveled outside the United States without a passport may not know the new requirements. Since it can take several weeks to obtain a passport, students are urged to apply now. Information about how to obtain a U.S. passport, and about traveling abroad, is available on the Department of State website at http://travel.state.gov. Although this new requirement applies only to air travel at this time, we encourage all Americans traveling abroad to have

It is also important for travelers to note that the Cricket World Cup will take place at various venues in the Caribbean for March 11, 2007 through April 28, 2007. Accommodations in many instances may be scarce or unavailable. We recommend that travelers exercise heightened security awareness as any large-scare public gathering could be the focus of terrorst acts or other forms of violence.

Travel safety is a major concern. Although most students will have a safe and enjoyable adventures, for some the trip will be a nightmare with a serious impact on the rest of

Each year, more than 2,500 American citizens are arrested abroad - about half on narcotics charges, including possession of very small amounts of illegal substances. A drug that is legal in one country may not be legal in a neighboring country. Alcohol can cause trouble for U.S. citizens traveling abroad. Students have been arrested for being intoxicated in public areas, for underage drinking, and for drunk driving. Some people are victimized because they are unaware of the laws, customs, or standards of the country they are visiting.

Disorderly or reckless behavior can have serious repercussions. It many countries, conduct that would not result in an arrest in the United States may constitute a violation of local law. Some Americans go abroad assuming that local authorities will overlook such conduct because they are American citizens. The truth is that Americans who violate the laws of the country they visit may very well be arrested, and they could face severe penalties, including long prison sentences. In fact, some countries have mandatory death sentences for drug offenses.

Being arrested is not the only misfortune that can occur on a foreign vacation. Americans have been badly injured or have been killed in automobile accidents, falls, or other mishaps. Although these incidents are sometimes chance occurrences, many are related alcohol or drug use. Other Americans have been sexually assaulted or robbed because of drug or alcohol use, or because they were the victim of a "date rape" drug. Other safety issues are of major concern as well. Standards of safety and supervision overseas may be different from those in the United Sates. Many Americans have died after automobile accidents on bad roads and after falls from poorly-fenced balconies. Americans should also exercise caution when swimming or engaging in water sports. Currents on both the Caribbean and Pacific Coasts of Central and South America can be swift and dangerous, in many areas there are few lifeguards or signs warning of dangerous beaches. In addition, travelers should be aware that tidal currents before and after storms are strong and unpredictable. Several American citizens drown each year due to riptides or sudden drop-offs while in shallow water. In some countries, the water sport and scooter rental industries are not carefully regulated. Visitors should rent equipment only from reputable operators and should insist on sufficient training before using the equipment. Every year, people are killed or injured by the improper use of scooters, jet skis, and personal watercraft or by the careless operation of such equipment by others. The exercise of simple common sense can help minimize risks.

Americans are strongly urged to register their foreign travel on the State Department's website at http://travelregistration.state.gov before the trip begins. Travel registration makes it possible to contact the traveler if necessary, weather because of a family emergency in the United States or because of crisis in the foreign county. Registration is a free service provided by the State Department and is easily accomplished online. (Note that in accordance with the Privacy Act, the Department of State may bit release information about a citizen to inquiries without express written authorization.)

Here's a question for all you pilots out there. How many times would you say you have simulated an engine failure? Almost certainly more times than you can remember. You have probably done it so many times that the routine maneuver is second nature. Well, now think of this: what if it really happens? No sweat - you know the emergency checklist by heart, you can handle the aircraft and make a textbook emergency landing into a field, right? So, if we practice engine failure simulations so often, how come we don't train just as much on what to do once we've actually crashed? The point is, statistics show that air crashes can be very survivable, but what is the purpose of surviving the crash if we are not prepared to survive the post-crash environment?

Most pilots don't like to think about the possibility that we might be involved in a crash, an ironic attitude considering that we train so systematically for the unthinkable. Despite our understanding of the risk, we continue to think

"the other guy." Although remote, the chances of you being thrust into post-crash scenario do exist. Statistics prove that proper preparation can greatly improve your chances of survival, particularly if your bad luck occurs in a remote area. You could be lucky and land in a neatly mowed golf course, or have a really bad day and end up in a dense forest or in the middle

of the ocean. So what can you do now? For starters, think about it. Read books or articles that deal with the subject of post crash survival, particularly the psychology of survival. Run through a scenario in your mind; it could help reduce the shock an anxiety that you will experience should the real thing occur. Become familiar with search and rescue procedures; This will give you an idea of how long your ordeal may last, greatly improving morale. Learn signaling techniques; being spotted early by rescue teams can mean the difference between life or death.

Think about how you would exit the aircraft after a crash, particularly if you are carrying passengers. Smoke inhalation and

that accidents only happen to fire are the primary causes of death for post impact survivors, so you definitely want to get out fast. The same goes for an over-water landing, a speedy exit is key to survival. Briefing the order that each passenger will exit the aircraft after an emergency landing/crash can save crucial time during the actual egress, and should be part of your preflight briefing.

It is also never too late to create a survival kit. If one is provided with the aircraft you fly, as is the case with ERAU aircraft, become familiar with its contents. After a crash is not the time to familiarize yourself with the emergency kit. If you are making your own emergency kit, make sure you tailor it to the environment that you'll be flying in (i.e. cold weather, mountainous terrain, desert, over water,

In the coming weeks, we'll be posting articles with specific information about post crash survival in common scenarios, including water ditching, as well as tips for making your own survival kit. Hopefully, you will all take the time to think about the unlikely event of a crash and how you would cope with it.



Keeping in line with the executive board's slogan for this year "Approachable, Visible, Committed", the SGA would like to inform the student as to how the SGA budget is comprised as well as how it is used to aid the students and university.

The SGA budget is a relatively simple concept on paper, you simply take the number registered as undergraduate students at the university and multiply that num-

generated the semesterly budget of the SGA. This budget is the direct responsibiliy of the SGA treasurer, Natalie Anaya, and the Finance

and equipment and operating costs of Eagles FM radio.

As for club funding, each semester the SGA treasurer and Finance Board are responsible for subsidizing recognized clubs of the university. Each club submits a proposal of requested funds and then petitions the Finance Board for funds. The Finance Board then holds a session in which they decide how best to dispurse the funds based on need, merit, activities, club fund raising efforts and variety of other criteria.

If you consult the bottom pie

The last large portion of the SGA budget falls under initial expenditures. This is the most diverse of the sections and includes many facets of SGA finances. Initial expenditures contain one time purchases or items that benefit the student body; such things as rent, to which the university is payed just over \$1,000 a semester for the use of the SGA office each semester. Initial expenditures also includes such items as telephone usage, printing, shipping, postage, equipment leases, computer equipment, and general office supplies totalling \$9,500. SGA travel, banquets and forums, such as the respective college forums with speakers each semester total \$5,500. Another approximately \$8,000 is used each semester for incentives for the staff of the various branches and divisions.

Also falling under initial expenditures is a devotion of \$40,000 each semester from which the Safe Ride program and the expenses of the coffee machine in the SGA office are funded.

In the following weeks, the SGA will post another report such as this including the spring 2007 SGA budget to inform you on how your \$85 SGA fee is being used to aid the students this semester. If you have any concerns, comments, or suggestions concerning this information, or that of the spring budget, please feel free to share your idea with Ryan Hattan at hatta5b6@erau.edu or Natalie Anaya at sgatres@erau.edu.







In a surprise move last week, Boeing announced that it has dropped its planned use of a wireless in-flight entertainment system for its upcoming 787 airliner, prompting more concerns over the jet's tight delivery schedule.

The WiFi in-flight entertainment ystem, based on the a similar WiFi technology that currently broadcasts wireless internet in millions of homes, schools and business, would have allowed up to 19 channels of video and audio content to be broadcast to individual seat back monitors using an array of broadcasting antennas throughout the aircraft. The wireless system previously was publicized as a means of increasing the flexibility and reducing the weight of the jet by eliminating lengths of wiring that would need to be restrung should an airline decide to change the seating configuration

entertainment system, citing concerns over the wireless systems performance in testing, as well as concerns over getting regulatory approval for the system, which could interfere with weather radar

in certain regions of the globe.
Ironically the removal of the various broadcast antennae, as well as a reduction in the thickness of ceiling panels needed to support the equipment will provide about

150 pounds in weight savings.
The flexibility of wireless system will be preserved in a wiring technique that allows the systems wires be mounted in the passenger seat tracks. Most airliners today use a network of under-floor mounted wires that need to be re-strung whenever seating configurations are changed. With this new system, should an airline need to reconfigure the jet, engineers would simply unplug the connection, slide the seat and plug the seat in at its new location.

The first new airliner in a decade

more conventional wired in-flight has been touted as the most technologically advanced commercial aircraft. News of the decision prompted more concerns by analysts that the aircraft's delivery schedule is slipping, Since the company's archrival, Airbus, has struggled to get its A380 super jumbo back on track after wiring problems prompted delays.

Boeing insists that the aircraft is still on track for its first

flight in August, with deliveries beginning in May 2008. 787 systems director, Mike Sinnet told the Seattle Times that the system will ease the delivery schedule as it is a less risky approach. Additionally, he stated that the problems with the A380 are of a completely different nature and scale. The A380 has over 329 miles of wiring compared to the just 61 miles on the 787.

Two private parties could purchase Airbus A380a

Last week, Aircraft manufacturer Airbus said that they had two potential buyers for their \$300 million dollar A380 superjumbo. Richard Gaona, vice president of Airbus' executive and private aviation unit, said that "they are not customers until they sign, but there are two very interested parties." Gaona added that one of the customers was in the Middle East.

"Airbus could sell 400 Flying Palaces and it won't save the problem," said Doug McVitie, managing director of Arran Aerospace, a Dinan, France-based consulting company. The superjumbo is over

two years late and will cost Airbus over \$8 billion dollars through 2010. Airbus' parent company, European Aeronautic Defence and Space Company (EADS), said that Airbus will record a loss for 2006, the first in the history of the company.

Airbus initially started offering its A319 as a corporate jet; however, they are now leaning towards offering their bigger aircraft, such as the A330, A340 and now the A380 Superjumbo. Airbus hopes to sell these large corporate jets particularly to people in the Middle East. Gaona said that the Middle East will represent 30 to 40 percent of private jet sales in the coming years.

Corporate and private aviation in

the Middle East is expected to grow 10 to 12 percent annually, and by 2012, the market will be worth \$800 million dollars - double its current

Airbus has also recently won two orders for its private VIP A340, one for the -500 variant and the other for the -600 variant. The names of the buyers could not be released, but Gaona said that one of them was indeed from the Middle East.

Airbus has had trouble in the past two years selling its four-engine A340, as most customers are leaning towards the two-engine A330 or the two-engine Boeing 777. The extra two engines on the A340 add extra weight, as well as increase fuel costs by 10 percent.

Safety license denied for new Bangkok International Airport

Aviation officials have recently denied an extension on Thailand's newest international airport safety license, another addition to the airports already long list of problems.

Suvarnabhumi, or New Bangkok International, has had problems with its tarmacs and runways. Many of the airports problems have actually occurred since it opened in September 2006. While they are still being repaired, the Department of Civil Aviation has deemed the airport unsafe for the time being, and as a result decided not to grant a renewal

Among other problems with the airport, Somachai Sawasdeepon, Suvarnabhumi's general manager,

has stated that the airport has yet to create a safety committee, which is required by the International Civil Aviation Organization (ICAO). When asked why, Sawasdeepon informed CBS the airport's authorities were 'busy solving other problems.'

Despite this, Sawasdeepon, has stated to CBS that he believes the certificate will be renewed after the safety committee is put into

Since the airport opened on Sept. 15, 2006, it has been plagued by several problems, ranging from overcrowding at the airport to the cracks in the taxiways and runways. These complications have caused a temporary revival of Bangkok's original international airport, Don Mueang International. Suvarnabhumi officials have continued to stress that they believe the airport is and from their planes.

Boeing nixes WiFi on Man dies in British new 787 Dreamliner Airways 747 wheel well

A man was found dead inside the wheel well of a British Airways 747-400 that had arrived at Los Angeles International Airport Sunday, Jan. 28th. A British Airways pilot who was doing a preflight check found the body and notified airport officials at about 4:30 p.m. The flight, British Airways 283, had arrived from London's Heathrow airport at 3:15 p.m. that day and was scheduled to depart back at 5:20 p.m.

The Tuesday after the incident, officials said that the body was that of 17-year old South African Samuel Peter Benjamin. The Los Angeles County coroner's office conducted an autopsy on that day, cause of death, although the mos probable factors are extreme cold and lack of oxygen.

The jet had arrived at London Heathrow from Cape Town pre viously, and had also been in Singapore and Hong Kong in the week prior to the incident. The body could very well have been in the wheel well for several days.

Turkey and Norway to buy F-35 Lightning

Two more countries to compete for contracts

Last week, Turkey became an official member of the F-35 Lightning II Joint Strike Fighter (JSF) program, signing a Memorandum Of Understanding (MOU) with the United States to participate in the aircraft's System Development and Demonstration phase. A few days later, Norway also signed the

The understanding allow the defense industries of Turkey and Norway to compete alongside the aerospace and defense industries of the United States, the United Kingdom, Australia, Canada, and The Netherlands for up to \$10 billion in contracts, as well as have input in design considerations. By press time, the two remaining partner nations, Italy and Denmark, have not yet signed the MOU but are expected to in the near future.

The countries that have signed

the MOU will compete for airframe construction and development, electronics and avionics, and information systems contracts, as well as new packages and upgrade programs through the program's expected 30-year lifespan.

Lockheed Martin Executive Vice President Tom Burbage, manager of the F-35 program, said that the "Turkish industry has been closely linked with Lockheed Martin and its heritage products for many decades," and that Turkey will be able to prove its continuing proficiency in defense technology in the coming years through signing the MOU. He went on to say that "Norway is a valued ally with an astute technical ability" that will benefit the F-35 program much in the future.

"With five countries now on

board, and more expected, this program is clearly fulfilling its promise of focusing the resources of multiple nations on a monumentally important defense capability," Burbage said in a Lockheed Martin

The stealth fighter is being produced in many variations, including a Navy version which may be launched from carriers, a Short-Take-Off-Vertical-Landing version for the Marine Corps, and a conventional version for the Air Force. The JSF program was conceived to replace strike fighters in all branches of many country's defense programs, like America's F/A-18, F-16, and A-10 aircraft, as well as Harrier jets in both America and the United Kingdom. More than 3,000 are expected to be produced.



NASA reported Saturday, Jan. 27, that one of the Hubble Space Telescope's main cameras had gone offline at 7:34 a.m., causing the observatory to enter safe mode to protect its systems.

At 2 a.m. the next day, the telescope was brought back online. Initial diagnostics indicated that the power feed to its Side B electronics package had shorted, blowing a fuse and rendering the Advanced Camera for Surveys (ACS), a thirdgeneration instrument capable of capturing light from the ultraviolet to near-infrared spectra, inoperable. A malfunction on June 30 of last year caused the primary, Side A system to be pulled offline, and the satellite has been using the secondary system ever since.

An Anomaly Review Board was formed on Jan. 29 to investigate the malfunction, and will formally present their findings March 2. Initial reports indicate that it is unlikely that the camera can be fully repaired, if at all; however, analysis of the problem is continuing. The camera was installed in

March 2002 and had an expected five-year lifespan.

Preston Burch, manager of the Hubble program, said that he was disappointed in the failure. The ACS was "the newest camera, the highest-tech instrument, and ... the one most in demand," he told Sci-Tech Today. He added that fully two thirds of the scheduled upcoming missions required the ACS. However, some of its functionality may be able to be restored, and some of its programs may be able

to be taken over by other instruments.

Space The Telescope Science Institute generated a list of programs last November that did not involve the ACS, so that, in the event of this kind of failure, the Hubble

the time left until the program must be dropped. These programs were implemented last week, and NASA reported that the malfunction will not spread to other instruments. including the Wide Field Planetary Camera 2, Near Infrared Camera Multi-Object Spectrograph, and the Fine Guidance Sensors.

Hubble Space Telescope Servicing Mission-4 is scheduled for September 2008, and while NASA officials are still officially unsure of what impact this failure

Sea Launch escapes catastrophe

An unexpected failure for the Sea Launch Program occurred last Tuesday when a Zenit 3SL rocket carrying a satellite erupted into an explosion aboard its platform which was located in the Pacific Ocean on the equator for launch. The rocket exploded during liftoff and immediately overwhelmed the Odyssey platform in flames.

The extent of the damage is constrained to the rocket and satellite, as the platform is cleared of all personnel before liftoff, controlling the launch from a remote ship miles away. Sea

Launch has declined to release the NSS-703 satellite will now stay in its cost of the satellite and the rocket.

The satellite onboard the rocket was the NSS-8 from the operator SES New Skies, a company that provides video, audio and Internet access for over half of the world, including Europe, Africa, the Middle East, Asia and India. Built by Boeing, the satellite was meant to remain at an orbital angle of 57 degrees and become the centerpiece of the New Skies global communications network, replacing the existing NSS-703 satellite.

SES New Skies is currently based out of the Netherlands and is operating five satellites which provide communications services to its customers. A report by New Skies said that the

Initially, Sea Launch declined to comment on the situation saying only that "The Sea Launch Zenit 3SL vehicle, carrying the NSS-8 satellite, experienced an anomaly today during launch operations. Sea Launch will establish a Failure Review Oversight Board to determine the root cause of this anomaly." In an official statement issued on Thursday, Rob Peckham, the president of the Sea Launch program, stated that "We deeply regret the loss of the NSS-8 satellite, which was designed to be a significant part of the SES New Skies fleet" and that "The

Sea Launch will continue to work diligently to understand the anomaly, identify the root cause and determine a corrective course of action. As we move forward, we are maintaining a positive, progressive mind-set and a dedication to excellence."

As of Sunday, the Odyssey and command ship were on their way back to their home port of Long Beach, Calif. Photos showed a scorched Odyssey with a missing flame deflector, but otherwise relatively unscathed.

Sea Launch has been successful on 21 previous missions since its maiden launch in 1999. The company is a joint venture between Boeing, Russia and Norway and is unique in its oilplatform-turned-launch-pad setup.

THEMIS makes final Earthly journey

Iran's space program, successful in their first objective of getting an Iranian satellite in the sky, is now pushing to get an Iranian satellite in space with an Iranian rocket.

According to a recent report in Aviation Week & Space Technology, the country may soon attempt their own satellite launch from within their borders on a converted missile.

In January, Iran's Sina-1 satellite was put in space using a Russianbuilt rocket. A second satellite, named Mesbah and built by an Italian firm, Carlo Gavazzi Space, is due to be put in space using another Russian

Both satellites will give Iran the capability of viewing the entire Middle East, as well as monitoring Israel. However, Iran has stated that the satellite carries no military purpose and cannot view objects smaller than 50 feet across. United States military satellites are capable of viewing objects a few feet across or smaller.

Iran points to America's use of satellites to monitor troublesome countries such as Afghanistan and North Korea, and argues their need to be a leader in aerospace for security purposes.

"We have to build our own satellites, our own launchers. We need to be one of eight top countries mastering space technology," said Ahmad Talebzadeh, the head of the Iranian Space Agency.

Iran has not been alone in trying to build their space program up to respectability; the Islamic nation has agreements with China, Russia, Thailand and North Korea. Russia has been the main trading partner of Iran, sharing space technology and knowledge with the newest member of the space community.

The prevailing concern of the United States and Israel has now shifted to the Iranians' capability of launching an Intercontinental Ballistic Missile, should they succeed in launching an Iranian-built rocket.

Iran's progress with nuclear technology and the threat of being able to launch an atomic bomb across Europe and the Middle East using their rockets, would be a powerful message to the Muslim world and the rest of the world. The possibility of UN imposed sanctions has spurred the country to accelerate their progress in space

Iran, however, has maintained that their space program has only humanitarian and environmental purposes. "The moment they feel Iran has made a breakthrough, they will impose restrictions more than those they have imposed on Iran's nuclear program,' said one space official, Mohammad Reza Movaseghinia.

The Shahab-3 missile, capable of reaching 1,000 miles, within striking distance of Israel, Saudi Arabia, the entire Persian Gulf region and as far west as southern Turkey, is currently being retrofitted for launch capability. No details are currently available on when this rocket will be launch

"We are at the very beginning of a long, long road in space technology. But we have the potential to develop an indigenous space program," said Mohammad Entezari, who is in charge of Iran's Mesbah satellite project.

NASA may do Apollo 8-like test

As an initial part of its Constellation Project, NASA is considering merging its two future rockets to test the performance of its capsule in a cosmic environment. This might include a manned lunar mission like Apollo 8, which flew in 1968, that would orbit but not land on the moon's surface.

The Ares 1 upper stage will be merged with the main stage of the Ares 5 heavy launcher, both latestgeneration launch vehicles part of the Constellation Project - NASA's space exploration program effective as of Aug. 26 – which will include the exploration and possibly colonization

The Orion Spacecraft, previously known as the Crew Exploration Vehicle, should be launched in 2015 aboard this hybrid rocket towards the moon, so as to study its performance in lunar orbit and in the space environment long before the first actual lunar

landings are scheduled to occur. The mission would be similar to man's first ever trip to the moon in Dec. 1968. Apollo 8 orbited the moon without a lunar lander and returned to Earth several hours later. Sending the spacecraft all the way to the moon would grant the experiment a much higher level of realism, and "you could have the capsule re-enter at lunar velocities," Scott Horowitz, NASA's associate administrator for exploration system and a former astronaut, told Space.com.

The Orion will also be tested in a skip-entry technique to re-enter the Earth's atmosphere. Generally, spacecraft enter on direct approach to the Earth and just pass through the atmosphere.

The goal of this new technique is to make the spacecraft "bounce" off the atmosphere before entering it, if desired. The Apollo lunar capsules returned on direct approach, which meant that, since they could only land in pre-defined locations on the Earth's surface, they had to launch from the moon within certain launch windows, greatly limiting the mission's flexibility. Seeing how NASA would prefer it if the Orion always landed in the same spot, this technique would greatly benefit the program.

Skip entry, though, is not without problems. According to Horowitz, it creates interesting technical challenges to the thermal protection system as well as control and guidance" for the craft.

Indeed, NASA will be using a replaceable thermal shield for Orion. and bouncing off the atmosphere creates mysterious stresses to date not fully understood, requiring further considerations in the design of the shield and, possibly, over-construction. This test will allow engineers to recover the shield after re-entry and examine it, perhaps partially explain-

appropriately. The hybrid rocket, along with other possibilities for high-speed skip-entry tests of Orion, are being studied at the Marshall Space Flight Center in Huntsville, Ala.



'Catch and Release' is quite the catch

"Catch and Release" makes no apologies for what it is: a romantic comedy with the requisite touches of a beautiful heroine, a set of humorous friends, an inappropriate love interest, and an obstacle to overcome. But it takes a while for you to figure out that this movie belongs in the genre.

Jennifer Garner stars as Gray, a woman success. Timothy Olyphant is particularly whose fiancee has died several days before their wedding. In an effort to pick the pieces of her life back up, she moves in with her two best friends and tries to resume a normal life. As secrets about her fiancee's past begin to unravel, Gray is forced to re-evaluate both her life and her entire relationship with the man she thought was the love of

The movie opens with the grim setting of a funeral wake. Garner sobs her way through the first five minutes, giving the audience cause to wonder if they just spent \$6.50 to wade through someone else's hysterical despair for the next two hours.

For the first 15 minutes, the film drags along, as tedious and unpleasant as an actual funeral. But the grim tone of the movie comes to a sudden halt when shocking secrets of Gray's fiancee are hurled out into the open. "Catch and Release" changes gears and begins to redeem itself, with Kevin Smith throwing out memorable, witty one liners that provide some much needed comic relief. Subplots start to emerge, including a new love interest and an unusual friendship, and the dark beginning slowly blossoms into an enjoyable film as Gray finally comes to term with her grief.


The plot of "Catch and Release" is entirely character driven and, luckily for the audience, all of the relatively unknown supporting actors shine with believable performances that make the movie an overall

memorable as the initially cocky and seemingly self absorbed best friend of Gray's

The town of Boulder, Colo. is featured so prominently that it nearly feels like another character in the film. The breathtaking scenery includes everything from the quaint downtown district to a roaring river snaking through evergreen mountains. By the time the credits are rolling, you're ready to buy a plane ticket and stake out the same places the characters did.

The film does have a few inherent weaknesses—namely, the lack of a villain. Apart from the cankerous, grieving mother of Gray's fiancee, played by Fiona Shaw, the audience encounters no adversaries beyond Gray's struggle to get over the death of her fiancee.

The ending of the film is unapologetically predictable and slightly saccharine, but in that comfortable way movies of this genre are meant to end. If you're a man being unwillingly dragged to see this movie with your girlfriend, know that you could do worse(See: "The Lake House") and count yourself lucky that there are enough humor and fishing metaphors in this romantic comedy to keep you awake. But if you're looking for a good chick flick that can happily measure up to predecessors such as "13 Going on 30" and "Elizabethtown," you'll be in good hands with "Catch and Release." In short, the "Catch" is worth keeping.
