SRB, SFB to see many new faces, SGA now a majority of women

After voting took place on the Flight Deck and on Blackboard Thursday and Friday, the students have spoken and the unofficial results of the SGA elections are in, and females are now in the voting majority.

More than twice the number of students than those who voted in the 2006 election turned out to vote in a new executive ticket, Student Representative Board (SRB) members and Student Finance Board (SFB) members. These results reflect the popular vote and are subject to change pending any campaign violations that may be reported.

The executive ticket, consisting of incumbent President Nate Clapper, Vice President Ryan Hattan, who will replace graduating Vice President Shawn Storey, and incumbent Treasurer Natalie Anaya will enter its second term. The trio bested the Kumar ticket, which consisted of Shaliesh Kumar, Zachary Smith and Jocelynn Dunn, by receiving approximately two thirds of 1,182

"We're very excited to have the opportunity to serve the students for another year and look forward to their continued involvement with the SGA. We hope to build on the successes of this past year and continue to move the SGA forward to promote the interests of the students," said the Clapper ticket in a joint statement.

The Clapper ticket ran on the platform of "driving the change, setting the standard," and plan to tackle several projects, including Safe Ride sponsorships, ATMs on campus, decreasing student debt and increasing club sport funding.

'We'd like to thank the Kumar ticket for an excellent campaign and look forward to any ideas or input they can provide to further the student government," said Clapper.

The SFB, which will be headed by Anaya, will see one of the biggest shake-ups. Three new members, Chelsea Longa, Kavita Patel and Elizabeth Seaman, will join returning members Lindsey Kurtz, Francesca Martino and Paul Zigler.

Hattan will head the SRB, which will also undergo a significant turnover.

The incoming College of Aviation (COA) representatives include returning members Pablo Alvarez, Ryan Baird, Nathan Mulder and current Task Force One (TFO) Vice President Angeline Ranieri. Newly elected members include Corinne Borsman, Lisa Brill, Joshua Cobb and current TFO Treasurer Erica Larson.

Clapper wins | Embry-Riddle student SGA elections caught in Polk sex sting

James B. Crosby, a 27-year-old senior in Engineering Physics, was arrested on April 1 in a Polk County sex sting that apprehended 28 people who were charged with various crimes related to soliciting sex from a minor.

Operation Cyber Hawk was led by the Polk County Sheriff's Office and included numerous other organizations, such as the Florida Department of Law Enforcement and the Internet Crimes Against Children

The operation took place over the course of a week, where Internet crimes detectives posed as 13- and 14-year-old children in chat

rooms. The detectives arranged to meet the twice in Jacksonville in the 1990s. He was suspects in a Polk County home, where the police department arrested the suspects.

The 28 suspects range in age from 17 to 55 and came from all over the state of Florida. One suspect even traveled from New Jersey. Crosby, who is supposed to graduate in

May, was charged with Soliciting a Minor Via Internet and Attempted Lewd Battery. In a telephone interview with *The Avion*, the Florida Department of Law Enforcement (FDLE) said Crosby holds no previous sexual criminal record.

This information about Crosby is in direct contradiction to an article written in the April 3 issue of the Daytona Beach News-Journal. The article in discussing the local suspects, stated that Crosby "was arrested

charged with fondling a child, aggravated stalking and fleeing and eluding police according to the Florida Department of Law Enforcement.'

There are two other James Crosbys in the state of Florida who are listed in the FDLE's sexual predator database and the Department of Justice's National Sex Offender Website. James A. Crosby and James R. Crosby.

James A. Crosby was charged in 2003 in Orange, Florida, with charges of Lewd or Lascivious Molestation and Lewd or Lascivious Battery for a person 12 to 15 years of age.

James R. Crosby, currently incarcerated

Quantum physicist talks and confuses on campus

The Embry-Riddle Arts and Letters series of speakers, in conjunction with the Fred Elston Fund, the Honors Program, and Thompson Publishing presented Dr. Lee Smolin in the sixth annual Elston Memorial Lecture on Gravitation, entitled "Finishing Einstein's Revolution: Three Roads to a Theory of Everything.

The presentation took place Saturday, April 7. Filling the IC auditorium is no small feat, but the promise of listening to a worldrenowned physicist speak on the past, present and future of our place and understanding in the universe drew men, women, students and families of the community.

Dr. Chris Vuille introduced the lecture in general by speaking for a few minutes about Fred Elston. He also noted how the man was a good man, kind and funny; Vuille said that while he might have not been as good a physicist as Einstein, he was

a better comedian than Bob Hope. Smolin spoke for about 75

minutes, moving through a history of our perceptions about the world and the universe around us through our current understanding and future possibilities. His style was engaging, funny, and as simple and broad as the topic could allow; the audience understood what he meant, or at least what he was trying to convey, as they laughed at his understated but persuasive sense of humor and his thanks for the baby in the audience who chose his lecture to be its first.

He began by defining "revolution" as a series of significant changes that take place over the course of generations. The current revolution, the Einsteinian one, began in 1905 with the development of quantum physics, relativity and atomic physics. The revolution continued with an expanding universe and particle physics; all of these things were unrecognized by the Newtonian view of the universe that had been around since the 1600s, and which had in turn replaced the Aristotelian view of a concentric universe.

Now, our views of time, space, matter, the universe and life are all again being reevaluated and changed, as our world changes in a more down-to-earth way, as well. The Aristotelian world view was hierarchal; just as there were kings and peasants in the world, so were there different celestial spheres leaving graduations between Earth and Heaven. In Newton's world of enlightenment, all men were created equal, and therefore all points and particles in the limitless universe were identical. Now, our views of the world resembles the internet, in that everyone is interconnected, and our views of the universe on a scale of minute fractions of a millimeter now resemble that as well.

This led to Smolin's thoughts on where we may go from here. The forces of the universe are beginning to be understood, but gravity continues to elude unification with the others. Work is continuing, and answers are by no means certain at this point. Smolin finished by saying that "One shouldn't claim too much" about what he or she knows, or thinks they've learned from the lecture that night. The revolution is in progress, and no one really knows where we will end up.

After a brief segment of ques-

tions, Vuille took the stage again to continue the tradition of honoring a student who has excelled in the field of quantum mechanics at Embry-Riddle. This year's winner was Yishi Li.

Double plays key in 2-2 tie with Cubs

DAYTONA BEACH, Fla.--Steven Howard drove in two runs in the fifth as Embry-Riddle played to a 2-2 stalemate in an exhibition with the Daytona Cubs.

The Eagles fell behind in the first inning, as Cubs' right fielder Chris Amador led off with a double and came home on a fielder's choice from Jesus Valdez. The Cubs added a run in the bottom of the fourth with back-to-back doubles from Mark Reed and Matt Matulia.

ERAU foiled another scoring opportunity in the fourth, as Chris Maloney induced Nate Spears to ground into a 4-6-3 double play to kill a rally. The Eagles turned two again the bottom of the fifth - with two on, Valdez hit a broken bat roller and a charging Michael Brady made a beautiful turn to start the twin killing. The third double play may have been the best, as Brady dove to his left to stop the ball, flipped it to Menchaca while still prone on the ground, and Menchaca finished the play with a throw that nailed Jake

Embry-Riddle tied the game in the fifth. With one out, Chris Trappy and Danny Martin had consecutive singles, and were bunted into scoring position by Joshua Menchaca. Steven Howard's second hit of the game, a double to left, scored both runners to knot the game. It was the first run scored of the season for Trappy, normally removed from the basepaths for a courtesy runner.

Howard moved to the mound in the seventh, and after issuing an intentional pass to load the bases,

ended the game with a groundout from Alberto Garcia.

The Eagles will be back in action on Friday, facing No. 19 Warner Southern over in Lake Wales. Currently, the Eagles and the Royals are tied for second place in the Florida Sun Conference with identical 9-3 league records. Both teams are one-game back of league leading St. Thomas, who stands at 10-2 heading into their weekend series against Savannah College of Art &

LAKE WALES, Fla.--Back-toback home runs in the bottom of the eighth inning from Dave Murray and Brad Menadier lifted No. 18 Warner Southern to a 7-6 win over No. 21 Embry-Riddle at Royals Field.

The Royals (24-16, 10-3 FSC) ended the Eagles' 14 game winning streak and lifted WSC into second place with the win. The Eagles sit in third, a game back of Warner Southern and two back of St. Thomas after their 8-1 win over

Warner Southern looked to blow the game open early, as Embry-Riddle starter Brian Letko issued four walks in the first inning. A 2-RBI double from Mark Davis and a sacrifice fly from Jason Caldwell boosted the Royals to a 3-0 lead. Letko escaped further damage when Murray hit a nubber back to the mound, starting a 1-2-3 double play.

The Eagles (31-7, 9-4 FSC) were hamstrung by WSC starter Ben Shockey, who allowed only four baserunners through the first four innings. Embry-Riddle finally broke through in the fifth, with a hit from Chris Trappy and a walk to Danny

Martin. Joshua Menchaca bunted them both over, and Steven Howard and Michael Brady drove them in with a groundout and a double, respectively.

Embry-Riddle took the lead in the sixth, as Colin Gray singled to extend his hitting streak to 16 games. The first of two doubles on the day from Trappy scored him, and a single from Martin plated courtesy runner Kevin Ferreiro.

ERAU added single runs in the next two innings - Howard scored on a sacrifice fly from Branden Roper-Hubbert and Menchaca grounded into a double play with runners on first and third.

Meanwhile, Letko worked out of bases loaded jams by getting Murray to fly out in the third and picking Davis off third to end the sixth. Steven Otterness (6-2) came in to relieve and countered a walk in the seventh by picking off Wes Lowry to end the inning, but could not hold the lead in the eighth. Caldwell singled and and Cassidy Turner walked, and after Tim Graeser popped out to center, Murray deposited the first pitch he saw over the fence in left to tie the score. Three pitches later, Menadier had done the same, clearing the wall in center.

Brett Stanton came on for the ninth and set the Eagles down in order. Letko finished with three strikeouts and five walks in six innings of work, while Brady and Trappy had three hits each for the Eagles.

A microscopic fungus attacks Canada

VICTORIA, B.C. - The mystery emerged slowly, its clues maddeningly diverse.

Sally Lester, an animal pathologist at a British Columbia laboratory, slipped a slide under her microscope - a tissue from a dog on Vancouver Island. Her lens focused on a tiny cell that looked like a boiled egg. İt was late 1999. She had started seeing a lot of those.

On the eastern side of the island, several dead porpoises washed ashore early the next year. Scientist Craig Stephen, who runs a research center on the island, slit one open. He found its lungs seized by pneumonia and its other organs swollen by strange, flowerlike tumors.

At work at the family trucking firm in Victoria, on the southern tip of the island, Esther Young, a lively 45-year-old mother, was feeling lousy in the fall of 2001. She had headaches and night sweats and was tired, her family said. The doctor told her she was pre-menopausal and it would pass.

All would become pieces of a medical mystery centered on a tropical disease apparently brought to North America by a warming climate. An alien fungus took root on Vancouver Island eight years ago and has since killed eight people and infected at least 163 others, as well as many animals.

Similar cases have been found elsewhere in British Columbia and in Washington state and Oregon.

Scientists say the fungus may be health problems: Peanuts from thriving because of a string of China had caused salmonella. Some thriving because of a string of unusually warm summers here. They say it is a sign of things to

"As climate change happens, new ecological niches will become available to organisms, and we will see this kind of thing happen again," said Karen Bartlett, a scientist at the University of British Columbia who played a central role in the search for the disease's cause.

Her investigation eventually would focus on a fungus, a member of the yeast family, called Cryptococcus gattii. The microscopic fungus is normally found in the bark of eucalyptus trees in Australia and other tropical zones.

Physicians in North America are familiar with a relative, Cryptococcus neoformans. In humans, it shows up through pneumonia when immune systems already are weak, most typically in AIDS patients. In dogs and cats, it can form abscesses below the eyes. Lester, working in her pathology lab in 1999, was used to seeing tissue specimens from six to 10 pets a year

But by 2000, vets on the island were sending her 10 positive samples a month. Lester knew Cryptococcus causes a disease that, like bird flu and West Nile virus, affects animals and humans. She put in a call to the British Columbia Center for Disease Control.

The call came at a busy time for Murray Fyfe. The head epidemiologist at the provincial CDC was then dealing with a bevy of other public

local spinach was tainted. And there was a surge of men coming to hospitals with diarrhea.

Fyfe consulted Pamela Kibsey, a microbiologist at the Vancouver Island Health Authority. Kibsey said she had noticed an increase in human cases of Cryptococcus. And there was something strange about it. It was infecting healthy people, not just the sick.

Fyfe formed a group to begin combing records of veterinarians and hospitals, tracing the first cases back to 1999. He asked Bartlett, at UBC, to join the group. They sent samples of the Cryptococcus recovered from diseased tissue for further analysis. The results showed it wasn't the familiar form of "crypto."
"This was an Australian fungus,"

Stephen said. "We said, 'What's a nice girl like you doing in a place like this?

More disturbing, the fungus appeared to be more virulent than in Australia. There, it infects about four people per million and is rarely fatal. On Vancouver Island, the rate was 27 per million, and it was more often killing people.

The scientists can only guess how, or when, the fungus arrived. It could have been brought on eucalyptus trees imported by nurseries from Australia. Or it may always have been on the island, quietly clinging to life unnoticed until the warm summers spurred it to proliferate.

"With global warming, it may have finally been able to emerge to a level (at which) it is infectious,



Fyfe said. Humans and animals living in the area, having had no exposure, had developed no immunities to it. Some people reacted to exposure by developing the disease.

Bartlett formed a team of students to try to find gattii in the wild. Armed with new detection kits ordered from Japan, they tramped through back yards on Vancouver Island, digging up soil, taking air samples, swabbing bark on trees. They went out with hour-long questionnaires to talk to survivors of the disease and to owners of infected pets.

One common site came up: Rathtrevor Beach Provincial Park. It is an expanse of moss-covered fir and hemlock trees that reach for the sky, cheered by ravens and gulls, next to the Strait of Georgia. Patient Esther Young had gone to the park to kayak. Several other patients had been there.

Fyfe helped the students swab an old Douglas fir at the park. Two weeks later, Bartlett called him, excited. The swabs had come back positive, the first discovery of

Cryptococcus gattii in the wild. By the start of 2003, Bartlett's students had found the fungus in other spots. They eventually concluded that it had infested a several-hundred-mile range on eastern Vancouver Island. Health authorities agreed with business leaders in the adjacent city of Parksville that it was no longer fair to target the park alone, and warning signs at the Rathtrevor Beach park came down in favor of a wider information campaign.

Health authorities still are struggling to strike the right balance with the public. "It's serious, but it's still a very rare disease. Much rarer than influenza, for example," said Eleni Galanis, epidemiologist at the B.C. Center for Disease Control. "People need to be aware of it, in order to treat it. But we don't want people to stop going outside.'

If doctors catch the disease early, oral doses of antifungal drugs will kill the cells. Undetected, the fungus can get into the spinal fluid, causing potentially fatal meningitis.

New cases on Vancouver Island have leveled off at about 25 a year. Eight people have died. Bartlett's focus now is to figure out whether - and how - the fungus is moving.

Five human cases have been found on the British Columbia mainland; two people have been sickened in Washington state; and Oregon has had two fatalities from a similar but not identical strain of *gattii*. Health authorities in Washington and Oregon say the disease is still too rare in their areas to warrant alarm, health threats."

but they are watching it. Bartlett said it is unclear whether the fungus has been tracked elsewhere on the bottom of shoes or in wheel wells.

"One possibility for what we are seeing on the mainland is the first colonization, like we had on the island in 1999," Bartlett said. Another is that those traces will disappear.

The infected porpoises - at least 25 of them now - suggest the fungus is carried by air over the water. Stephen Raverty, a pathologist at the provincial veterinary center in British Columbia, worries that the fungus can attack other species.

Killer whales, whose numbers have dropped sharply here, are cetaceans like the stricken Dall's porpoises. Raverty and others have been tracking the killer whales in Puget Sound, using glassine slides mounted on long poles to catch droplets from the whales' exhalations, to see whether the animals have been infected.

So far, they haven't found the fungus. But animals can act as a sentinel for humans, the scientists say.

Wounded veteran gets a second chance at life

CONTINGENCY OPERATING BASE SPEICHER, Iraq - The soldier woke up at Walter Reed Army Medical Center in October 2004 with no memory of the ambush or his trip home from Afghanistan. Every bone in his face but one was shattered. He was drugged and delusional, eating and breathing through tubes. In four days, Army Lt. Drew Sloan had lost

As the doctors reduced his medications, Sloan regained his lucidity and learned what had happened. He had been riding in the back of a Humvee in south-central Afghanistan on Oct. 10, carrying ballots from the presidential election the day before. Staff Sgt. Brian Hobbs sat in front, with Spec. Joey Banegas manning the .50-caliber machine gun in the turret. As they reached a creek bed surrounded by mountains, gunfire erupted. A rocketpropelled grenade slammed into the front of the vehicle.

The concussive force of the explosion burst through a weak point in the Humvee's armor. The rush of air smashed Sloan in the face, cracking the bones in hundreds of places like a shatterproof window struck with a baseball bat. His cheek was torn open. His jaw dangled unnaturally. Blood spurted everywhere. His palate was pulverized, teeth destroyed, the results of nine years of childhood orthodontics wiped out.
"Blow through! Blow through!"

Hobbs yelled, but the Humvee's engine was dead. It rolled to a stop, on fire. Twenty or so Afghans emerged from the wood line, firing AK-47 rifles. Banegas shot back before he noticed Sloan in the back seat, halfconscious. Banegas pulled his platoon leader from the vehicle as the bullets

"Don't drop me, Banegas," Sloan said at one point, according to a letter he wrote congratulating Banegas for being awarded a Bronze Star for valor in the incident. This account of Sloan's experiences is based on interviews with him and others over nearly

The second Humvee in their convoy arrived, but the Americans were isolated, their radios blocked by the high mountains around them. The firefight raged for 30 minutes before the attackers pulled back. Nearly a dozen U.S. soldiers crammed into the remaining Humvee, with Sloan slumped in the front and others hanging on the roof. They made it to a small police station a few miles away. Sloan was flown by helicopter to the U.S. military base at Kandahar, then evacuated to Germany and finally to Walter Reed.

At this point in his life, Sloan had become the person he had long hoped to be - a top graduate of the West Point class of 2002, an airborne Ranger, a platoon leader in combat. "I wanted to do something that was not only bigger than myself, but also different from anything my peers were doing or anyone in my family had ever done," he wrote later.

In a fleeting moment he couldn't even recall, he had been reinvented as a hospital patient. Over two months

at Walter Reed, and in the year and a half of operations and physical recovery he endured afterward, he realized that rebuilding his body was only half of what he needed to do. Becoming whole again would require returning

In early 2005, Sloan went to Hawaii, where the 25th Infantry Division is based, and was selected to be the aide to Brig. Gen. John M. "Mick" Bednarek, one of the division's two deputy commanding generals. Sloan ran Bednarek's calendar and handled the small details of military life.

A year passed, time Sloan used to plan and put his life together. He would have one surgery to reconstruct his face, recover and work, and have another surgery. He was self-conscious about his scars and appearance. He was still missing teeth, and his eyes were cross-eyed for months as a result of the aneurysm. At one point he walked with a cane after surgery to transplant bone from his hip to his palate. He got along well with Bednarek, who worked Sloan hard enough that he had little time for a personal life. By summer 2005, he wondered

whether a long-term military career was his true calling. Few of his West Point friends planned to stay in past June 2007, when their commitments

"The truth is I don't know," Sloan said during an interview in July 2005. "It's hard for me to get out because of West Point. The nation's at war but at the (same) time, do I think this is quite the best place for me? There's other things I want out of life, like grad school, a family. And if I'm going to Iraq every other year, that's a lot

He still wanted to go back to combat, but not out of vengeance. He didn't think much about the fighter who had fired the grenade at him. "If the situation was reversed, I would have fired at him," he said later. "That was life in Afghanistan; that was life in war.'

Sloan believed in America's wars. He thought of his duty in Afghanistan as the honor of his life and that the global threat of Islamic fundamentalism was real.

Sloan's unit got its orders: Iraq for a year, starting in summer 2006. Sloan, promoted to captain, told Bednarek he was making plans to leave the Army in 2007 and would apply to business school. But he had a request. He wanted to deploy to Iraq first.

"Okay," Bednarek said. "I understand what you're asking.

They would go to war together.

January, Sloan logged onto a computer at Camp Speicher to see whether he'd been accepted to gradu-

"We've got a Harvard man!" Bednarek bellowed in the division headquarters. Sloan had been admitted to the business school, and would be out of the Army by summer.

The next month, Bednarek's small staff fanned out around the world for two-week, mid-tour leave. Sloan went to Africa, where he climbed Mount Kilimanjaro with a cousin and a friend, looking as civilian as anyone else on the trip, with a solar charger for his iPod and speakers mounted on his North Face backpack. His facial scars had largely healed, and his hair was long for the Army. It was only when his fellow climbers asked where he'd flown in from that the war came

Later he went scuba diving in Kenya, and there was no blending in. He stood in his bathing suit, his scars revealed. A vertical line on his stomach exposed where a feeding tube had been inserted. A dimple over his windpipe betrayed a tracheotomy.

You look like you've been in the wars," the dive instructor said casually. "What was it, a car wreck?"
"No," Sloan replied. "You were

right the first time. It was war."

New Hip-Hop Christianity

MORENO VALLEY, Calif. -- He goes by the name of Pastor Flo. As he stood in the pulpit of the Hip-Hip Sanctuary New Generation

Church, all eyes were on him. "They say we can't have hip-hop and church," said Flo, a lay preacher whose real name is Roosevelt Sargent. 'I say this is real church. It's just presented by and for the hip-hop community, but don't get it wrong, this is a place of praise and worship

In the dimly lighted church, a chorus of agreement rang out.

Murals of the Last Supper dangled from the wall. A deejay scratching bass-booming, wall-thumping music worked from the pulpit. Churchgoers wore do-rags and New Era fitted hats. Their hands clutched worn Bibles.

With traditional churches seeking ways to revitalize interest in worship -- particularly among the young -- the distance between hip-hop and religion is closing.

And although some churches in mainly urban areas devote portions of services roughly every month to hip-hop congregations, this Baptist

church in Moreno Valley is one of the first to present its worship services in hip-hop terms.
"What this indicates is the fact that the black church recognizes that

religion to black youth," said Todd Boyd, a professor of critical studies at the University of Southern California and author of "The New H.N.I.C.: The Death of Civil Rights and the Reign of Hip Hop." "It's a case of them recognizing that their message is old and tired, and hip-hop gives them an opportunity to reach a new

Felix Roger Jones III, pastor of All People Unity Baptist Church in nearby Redlands, says he has concerns about hip-hop-oriented churches based in large part on the mainstream segment that glorifies violence, street gangs, lavish lifestyles and misogynic views.

"My ears are up as to what individuals who call it hip-hop church are about," he said. "It is a gimmick to an extent. Are you preaching from the word of God, are you disciplining people like Jesus did, or are you just trying to experiment with hip-hop?"

Flo, 33, says he has received plenty of e-mails and phone calls discounting his methodology.

"You already have rock 'n' roll Christianity, old-school Christianity, country Christianity," he says. "How can there be all these different types of Christianity and no room for hip-hop Christianity? And these kids who go to church and sit in the back will only be there for so long. The next step is out the door.'

Flo used to be one of those kids out the door. He fathered his first child hip-hop has more of an appeal than at 15, messed with gangs and saw three brothers and his father incarcerated for long periods. He moved from Portland, Ore., to the Inland Empire to escape the culture that had seduced

He has dabbled in the hip-hop church movement for more than a decade, after his former girlfriend's grandmother asked him to read the scripture with her. He dreamed of starting the church last year, opened it in January and plans to open a branch in Compton soon.

More than 300 people packed the church's grand opening. The event featured hip-hop pioneer Kurtis Blow, who tours the country establishing hip-hop churches.
"We were messing with some fire

codes that night," Flo says.

After finishing the opening greeting on a recent Thursday night, Flo introduced Young Pro, born Santiago Abarca. The 21-year-old Riverside artist

travels from church to church performing and testifying about his faith.

Midway through the performance seven teenagers sheepishly sauntered into the church. They hesitated before taking a seat in the back pew. Flo led the congregation in prayer

and three of the young people removed their baseball caps, two turned off cell phones and all bowed their heads.

Flo discusses a passage from the Gospel of Matthew, in which the disciples are stuck on a boat during a storm and Jesus gives Peter the faith to walk on water.

"This is church, so we do read the Bible a little bit," Flo said. "Now, the disciples were probably tripping when they saw him walking on water. The word doesn't say that, but y'all know what I mean. What he was doing was training his disciples by faith, because that is what he does.'

Prayer was over. Heads rose. Hats snapped back onto heads.

Flo invited the congregation to come to the pulpit to rhyme expressions of their faith and dance to the booming bass. While other members of the congregation handled the microphone, the teenagers took turns krumping -- doing a highly energetic jerky and expressive dance -- and a circle of onlookers quickly formed around them.

"We weren't going to be doing anything but watching cartoons on TV," said Alexander Pruitt, 19, who said his friends belonged to a krumping crew and learned about the church through MySpace. "We thought this was going to be a big event, like a party. We ended up being the party."

The church emptied and the congregation spilled outside after another high-energy service.

'This isn't an alternative to the traditional church," said Diane Mooney, whose daughter, Cheris, and friend Amber Harrell-Tobey performed during the service. "But it does show that this type of generational transition is in the forefront.'

The Virtual Air Traffic Simulation Network (VATSIM) is the world's largest online flight simulation network. With seven regions, including a European region, Asian region, North, South and Central American regions, African region and Oceanic region, VATSIM encompasses the entire globe. Each region is comprised of division. There are 18 total divisions, including VATUSA in the North America division, which includes all 21 ATRCC's in the continental United

VATSIM users can fill either the virtual pilot or virtual controller role using a flight simulator, such as Microsoft's Flight Simulator, or a radar-screen simulator such as Virtual Radar Client. Communications between pilots and controllers are executed using a voice-over-IP client or text messages.

The network strives for reality, and procedures for air traffic control are followed as closely as possible to the FAA real world procedures and letters of agreement, including picking up clearances prior to departure and having approach, delivery and center controllers. Phraseology is followed to the T by controllers as required by the FAA for real world controllers. Training is required to become a controller to ensure proper procedures.

Pilots range from general aviation pilots to virtual airlines including Delta, United Airlines. Embry Riddle even has their own VA, Embry-Riddle Virtual Airlines, flying most of the common aircraft found on the Riddle Ramp or in the FTDs including the C-172, Piper Arrow, Bombardier CRJ, Boeing MD-90 and the sport aviations Aviat Pitts and Piper Pawnee. Many add-on clients are available simulating passengers and Traffic Collision Avoidance Systems (TCAS). Each facility holds events such as Friday Night Ops or fly-ins for major events like Mardi gras, which will max traffic to realistic levels and force aircraft to be sent into holding or ground holds

VATSIM was created by George "Pook" Barney in 2001 with only two clients as its interface. Shortly afterward, Roger Wilco, a voice-over-IP client, was born, enabling voice communications and bringing a new reality to the simulation. It has since grown to a virtual mirror image of the real world aviation community.

Many pilots and controllers learn on VATSIM before flying/controlling in real life. VATSIM offers both controller and pilot training as well as a number of resources for both. Pilots can look up real world routes flown from www.simroutes.com, and navigation information from www.airnav.com.

The Fuel Cell Demonstrator

Airplane research project has been conducted by Boeing Research and Technology - Europe (BR&TE), part of the Boeing Phantomworks, since 2003. The aircraft will have a maximum speed of about 62 miles per hour and will span about 50 feet. Test flights will take place in

Specifically, the demonstrator will use a Proton Exchange Membrane fuel cell and a lithiumion battery to operate an electric motor. 

New American spaceflight duration record set

A new resident crew and an American billionaire rocketed into orbit Saturday to begin their stay aboard the international space station. The Soyuz rocket carrying the two Expedition 15 crewmembers lifted off from the Baikonur Cosmodrome in Kazakhstan on time at 11:31 p.m. local time, lighting up the barren steppes surrounding the launch site.

Onboard were cosmonauts Fyodor Yurchikhin and Oleg Kotov, who will relieve two Expedition 14 crewmembers and begin their six-month stay aboard the ISS. Also onboard was the world's fifth space tourist, Microsoft pioneer Charles Simonyi, who paid the Russians an estimated \$25 million for the 13-day vacation.

After a two-day chase of the space station, the Soyuz TMA-10 mission capsule was to have docked to the outpost Monday. Yurchikhin and Kotov will relieve outgoing residents Michael Lopez-Alegria and Mikhail Tyurin, who have lived aboard since September. Simonyi will depart the station with them April 20 after his 13-

În Lopez-Alegria, a new champion emerged last Tuesday as NASA broke its previous single duration record for an American

Lopez-Alegria was cheered for having stayed in orbit aboard the ISS for 197 consecutive days, breaking the previous 196-day record held by astronauts Carl Walz and Dan Bursch of the Expedition 4 crew.

Commander of Expedition 14, Lopez-Alegria launched September 18 and is scheduled to return to Earth April 20, raising

day stay in space.

Lopez-Alegria has been warned, though – and is fully aware – that his glory will only be temporary. 'I have a feeling my record isn't going to last for long, and I know exactly who is going to break it,"

he told *Space.com*.

Astronaut Sunita Williams, currently the Flight Engineer in Lopez-Alegria's crew and subject of the commander's remark, will not be leaving the ISS with the rest of Expedition 14, but rather will remain on board as part of Expedition 15. She is scheduled to leave orbit aboard Endeavour later this summer, and by then she will have set a new American record. The will also own the world record for a woman, surpassing

his record to an impressive 214- famed astronaut Shannon Lucid's duration aboard Mir.

Moreover, certain delays in the launch of the STS-118 mission that was supposed to carry her home will increase her stay even further.

Neither of the players will be thrown completely into the shade, though. As it stands, Lopez-Alegria tops the charts for having the most spacewalk hours - 10 instances totaling 67 hours – while Williams holds the record for most spacewalks performed by a female astronaut – 4 totaling 27 hours.

Historically, however, the longest single space mission award remains in Russian cosmonaut Valery Polyakov's name, with an astounding 438 days in orbit aboard the Space Station Mir in 1994 and 1995.

A few grams of ashes from actor James Doohan will finally be launched into space on April 28 2007. James Doohan died in June 2005 after suffering from pneumonia and Alzheimer's disease. Mars missions simulated on Earth

Imagine being locked up in a tube for 500 days in a row, with limited communications with the outside world. That is exactly what six people – chosen from a pool of volunteers – will be asked to do as part of a joint Russian / European research project.

The idea is to simulate a mission to Mars as realistically as possible to study the potential issues - and solutions – which might arise in an actual mission. The program, Mars500, was organized by the Russian Institute for Biomedical Problems (IBMP) and contributed to by the Russian Academy of Sciences, with the European Space Agency (ESA) recently the Russian institutions.

ESA interest in the program, as explained by scientist Marc Heppener to Space.com, will revolve around the psychological and physiological effects of such a trip, namely motivation changes; effects of stress on health; effect of confinement on sleep and mood; and possible changes in the immune system.

The program will simulate a launch, journey to Mars, research trip to the surface, and return trip. All factors will be kept as close to reality as possible, which means that the crew will have to handle a limited food supply, 20-minute delays in communications, and simulate emergencies.

One of the crew members will have real medical experience, and


