#### Quayle May be incharge

The chairman of a House subcommittee on space is protesting a policy proposal that he says would put Vice President Dan Quayle, not the head of NASA, in charge of the nation's space program.

Rep. Howard Wolpe, D-Mich., wrote President Bush that a proposed policy directive effectively makes the vice president ... not the administrator of NASA or the secretary of the Department of Defense, responsible for reporting space program deficiencies to Congress."

But the National Space Council, which Quayle heads, said it only circulated the proposal for comment and has not endorsed it.

The proposal was released Jan. 1. Less than two weeks later, a longstanding power struggle between the space agency and the Space Council culminated in the forced resignation of NASA administrator Richard Truly, offective at the end of this month.

Wolpe, chairman of the investigations subcommittee of the House Science, Space and Technology Committee, warned that if the vice president assumes such responsibility "the Congress will surely summon him as a witness to testify at fumre bearings on problems in NASA and Department of Defense space activities."

Vice presidents have testified only rarely before congressional committees.

The Space Council said the proposal was one of many that come to the council unsolicited and that it was among many concepts circulated for comment to an Interagency group as it formulates a new national space policy for the

Wolpe claims the changes would violate the National Space Act of 1958 which assigns responsibility for civilian space activities to NASA and for military space activities to Defense. It also would violate a section of the law that gives the NASA administrator control of activities and personnel.

In his evaluation, NASA administrator Richard Truly said the Space Council's reporting to the Congress on individual programs would erode his fundamental accountability for space programs.

"It would be extremely disruptive to an orderly program management process," he said.

#### Mir must be replaced

A top Russian space official says the 6-year-old space station Mir must be replaced in a year and a half and suggests turning to the West for help, a newspaper reports.

Yuri N. Koptev's comments in Izvestia on Thursday were the latest dismal report on the once-proud Soviet space program.

Earlier this week, military construction troops rioted at the launch facility in Kazakhstan in a protest over low pay, bad food and hazing. Three people died.

One of the two cosmonauts aboard the Mir is approaching a new space duration record involuntarily because the turmoil back home on Earth has delayed his replacement. Both are to return next month.

"Mir has been in operation for a long time," said Koptev, general director of the Russian Space Agency. Its base module will have to be replaced within 12 to 18 months. It is an expensive project.

We do not exclude attracting foreign capital and forming a joint stock company for joint use of the Mir station," he said.

#### Astronaut Blaha visits Embry-Riddle to promote new Space studies minor

Last night Air Force Colonel John Itlaha spoke to a full audience in the University Center.

NASA, Blaha, an Air Force Colonel, first received his wings in 1967 at Williams Air Force Base in Arizona. Subsequently, he was assigned as an operational pilot flying F-4, F-102, F-106 and A-37 aircraft, completing 361 combat

missions in Vietnam. Blaha has logged flight time in 34 different aircraft. He has earned the Air Force Distinguished Flying Cross, the British Air Force Cross, the Vietnam Cross of Galantry, the Purdue Engineer Astronaut Alumnus Award, the NASA Exceptional Service Award and two

NASA Space Plight Medals.

Blaha was selected as an astronaut in May 1980. His first assignment was to the space shuttle ascent/entry development team where he led the Student Government design, development and integration of the Orbiter Head Up Display System, In 1983 and 1984, Blaha worked as an ascent, orbit, planning and entry Capsule Communicator in the Mission Control Center for seven shuttle flights.

Blaha became a Space Shuttle Commander and began training for his many missions.

"Research is the most important thing," said Blaha while speaking of future NASA endeavors in space.

When asked about the end of the Soviet competition, Blaha stated that 'I'm glad to be an American." This was in reference to the superior quality of American technology-Also, the Soviets were not competition because they had decided to take a different route than the United States.

Blaha mentioned that he had recently visited the ex-Soviet Union, and discussed space exploration with cosmonauts. When speaking to a cosmonaut from a Soviet space station, he discovered that long-term exposure to microgravity appears to have little effect on the human body if exercise is regulated each day.

When Col. Blaha was asked what was his opinion of the major problem that NASA faces, his answer was very interesting. Blaha believes that NASA faces a 'credibitity gap" following the Challenger accident.

# **Endeavour prepares** to launch in early May

NASA's newest Space Shuttle, Endeavour, began its journey to its first mission when it was transfered from Orbital Processing Facility (OPF) bay 1 into the transfer isle of the mammoth Vehicle Assembly Building (VAB). Endeavour traveled the several hundred yards from the OPF to the VAB in just over 30 minutes, early Saturday morning. Endeavour was moved aboard the orbiter transfer vehicle.

"There's no question in my mind that the team went the extra mile in getting Endeavour ready to leave the OPF. The team grabbed the challenge in getting a brand new orbiter flight ready, overcame many obstacles and demonstrated tremendous teamwork. We're proud of the team and happy to see Endeavour on its was to the launch pad," said Jay Honeycutt, Director of Shuttle management and Operation.

Endeavour arrived at the 1991, several days after it rolled off the assembly floor of Rockwell International in Palmdale, California. Many systems onboard Endeavour feature design changes or updates as part of continued improvements to the space shuttle.

The upgrades include several improved or redesigned avionics systems, the drag chute, and modifications to pave the way for possibly extending shuttle flights to last as long as three weeks.

The vehicle will spend about six days in the VAB while technicians connect the 100-ton space plane to methods.

its already stacked solid rocket boosters and external tank. Endeavour will be transferred to newly refurbished launch pad 39-B. This marks the first use of pad B since it served as the launch pad for Columbia last June.

A Flight Readiness Firing (FRF) is planned about a month after Endeavour arrives at the pad. This 20-second test firing of the shuttle's main engines is a required test of all new shuttles to verify the integrated operations of the three main engines, the main propulsion system and pad propellant delivery systems.

After the FRF, technicians will perform extensive inspection of Endeavour's main propulsion system and main engines to make sure the systems are flight ready.

Routine operations and tests are planned while at the launch pad. This includes the Terminal Countdown Demonstration Test with the STS-49 flight crew, which is tentatively planned about four days after the FRF.

Endeavour's seven-member crew will be commanded by Chief Astronaut Dan Brandenstein, Kevin Chilton is the pilot and the five mission specialists are Rick Hieb. Pierre Thuot, Kathy Thornton, Thomas Akers and Bruce Melnick.

Endeavour's maiden voyage, set for launch in May, will be highlighted by three spacewalks, the greatest number ever performed from a shuttle during a single

### Pioneer 10 still carries a message after 20 years

Pioneer 10 set out for Jupiter 20 years ago today, carrying a message from earthlings, just in case,

The nuclear-powered spacecraft is now five billion miles farther from Earth than any other human-made object and still beaming back precious scientific data as it hurtles deeper and deeper into space.

"The great technical miracle of the whole thing is that we can receive intelligible data from five billion miles away using only eight watts of radio power. That's a great human achievement," University of Iowa physicist James Van Allen, principal investigator of one of Pioneer 10's telescopes.

"It's mind-boggling and aweinspiring," said B.J. O'Brien, a retired engineer who managed the program for satellite maker TRW

The faint radio pulses eventually will disappear and power to the scientific instruments will cease, probably around the year 2000. But Pioneer 10's odyssey will go on and on, barring collision or capture by space beings.

No one knew what to expect when Pioneer 10 was hoisted into space by an Atlas-Centaur rocket on March 2, 1972. The 570-pound craft was designed to operate for a minimum 21 months, just long enough to fly by Jupiter and take pictures of the mysterious, giant

NASA worried whether the aluminum and magnesium probe would make it through the asteroid belt, a massive band of rock and dust orbiting between Mars and Jupiter. A spacecraft had never passed this way before.

Pioneer 10 entered the asteroid belt in July 1972 and emerged unscathed seven months later. The spacecraft survived another trial in December 1973 in Jupiter's intense radiation belts.

The probe swept safely within 81,000 miles of Jupiter and provided the first close-up views of the cloudcovered planet. The planet's gravity propelled the craft toward the outer reaches of the solar system.

When Pioneer 10 crossed Neptune's orbit in 1983 it become the first human-made object to leave the solar system. If it continued on its path,

would pass within three light years of a star called Ross 248 in 32,610

Seven of the probe's 11 scientific instruments still work, including Van Allen's telescope. They monitor solar wind, cosmic particles and ultraviolet glow. Scientists scrutinize the data for evidence of a 10th planet and signs of the heliopause, the outer limits of the sun's influence.

"We're still seeing the influence of the sun," said Van Allen, discoverer of Earth's radiation belts. "In a gross sense, that's the major finding since we left Jupiter. The solar influence extends to distances far beyond what were previously anticipated."

Millions and millions of pages of data have been received over the years, said Richard O. Fimmel, NASA's Pioneer project manager.

Pioneer 10's radio signals take 7 1/2 hours to reach Earth, The eight watts of power in each signal is the equivalent of a night light. By the time the signal reaches Earth and the huge antennas of NASA's Deep Space Network, the power measures 4.2 billionth of a trillionth of a watt.

Signals are received once, sometimes twice, a day. They show up as numbers on computer screens in the small Pioneer mission control room at NASA's Ames Research Center in Mountain View, Calif. At least once a day the staff sends up commands, messages that take 7 1/2 hours to reach the craft.

For anyone or anything that might be out there, Pioneer 10 bears a plaque. It shows a naked man and woman which caused a fuss at the time of launch standing side by side, The man's right hand is raised in

The nine planets also are depicted, as well as the spacecraft's path. A burst of radiating lines indicate the distance and direction from the sun to 14 pulsars, or pulsating stars, and the frequency of those pulsars at the time of launch.

NASA spends about \$1 million a month managing Pioneer 10 and five other Pioneers: Pioneers 6, 7 and 8 orbiting the sun; Pioneer 11 speeding beyond solar system after sweeping Saturn; and Pioneer 12 orbiting Venus. Pioneer 6, launched in 1965, is the world's oldest

operating spacecraft. At the time Pioneer 10 and 11 barreling along at 28,900 mph, it was built, they cost \$100 million.

The Aircraft Owners and Pilots Association (AOPA) has put an emphasis on helping aspiring flight instructors as well as those who are already certified to instruct.

The Air Safety Foundation, operated by AOPA, is planning on increasing the number of sites of their Flight Instructor Refresher Clinics to cities around the U.S. to 83 in 1992. Most of the new locations will be in the West, including Salt Lake City and several cities in California.

The popular classroom revalidation course offered to CFIs is now being opened up to commercially rated pilots who are prospective instructors. This comes in response to the 30 percent failure rate nationwide of first-time CFI applicants. This rate reaches as high as 90 percent in some FAA districts.

"By reducing course tuition to \$100 for non-CFIs, we hope to encourage their early participation, thereby improving their eventual performance during FAA practical tests," said Frank J. Whyte, Foundation vice president,

The current price of the weekend clinic is \$135 for the revalidation program.


Soventy-five hundred flight instructors attend the Air Safety Foundation's courses each year. The large number of applicants allows them to recruit some of the best instructors in the country.

In operation since 1976, the course now emphasizes regulations, airspace, instructional techniques and human factors.

"FAA inspectors tell us that the majority of these failures involve applicants who may have the flying skills, but lack the in-depth knowledge of the wide-ranging subject matter expected of CFIs, commented Whyte.

Those attending the course receive a reference library to support their next two years of flight instructing.

Although the 40th Annual Experimental Aircraft Association (EAA) Fly-In is a little more than four months away, now is the time to make plans for this event. With the massive attractive force this airshow has with the public, early preparation would be wise. You do not want to miss out on the best airshow in the nation, held this year from July 31 - August 6.

The driving force behind the success of the Convention, held in Oshkosh, WI, is its diversity, For those who just like to stroll amongst the aircraft, approximately 13,000 aircraft attend.

Aircraft including homebuilts, antiques, Warbirds, ultralights and aerobatic performers can peek the interest of anyone. One can easily spend an entire day along the 8,000 foot flightline inspecting all the aircraft.

The diversity does not stop with just the aircraft. It carries over to the draws individuals from many foreign nations.

At the international flightline, one could meet a pilot who flew the entire trip from Germany or speak with a commercial pilot from Australia. No other airshow has as much international attention or par-

The EAA offers much to the public to increase the diversity already present. Hundreds of forums and seminars are presented throughout the show to the public. These informative lectures will spark the interest of pilots, mechanics and engineers with topics such as navigational aids, fiberglass molding and new composite structures brought into light.

The four exhibit halls are packed with national manufactures of aviation accessories showing off the latest products. This allows the visitors to get a "sneak peek" at what is available to them. Over in the Fly-Market, articles

such as clothing, aviation books, posters, memorabilia and used aircraft parts may be purchased. The main attraction at the EAA

shows themselves. Each day has a scheduled list of performances.

On occasion, aircraft manufactures will fly their products during an airshow as a way to give the public a chance to see what is available on the market. Performances from some of the top aerobatic stunt flyers also contribute to the schedule.

Each day has a different theme which allows a different style of aircraft to be emphasized.

One day the antiques get to fly. and then the next day the homebuilts have an opportunity to steal the spot-

The largest and most popular airshow is given by the Warbirds. Aircraft previously used in military service as well as ones currently in service are flown for an entire after-

Since the airshow draws a little less than one million spectators each year, one should make plans early.

The Convention has several options for those wishing to attend. The first is the campsite which the EAA operates. People from around people who attend. The Convention the nation drive to Oshkosh and camp at the airshow.

The second option is for those who wish to fly to the convention. The EAA does have a facility to tie down aircraft and the EAA allows the owner to camp out under the wing. The last option is to stay at a hotel in the area.

Since all these options can only accommodate so many people, time is critical. If you wish to attend the airshow, you should act now.

#### Begin: Steetfighter, gentleman, emotional intellectual.

JERUSALEM - Menachem Begin was part scrappy streetfighter, part courtly European gentleman. He was a Churchillian orator with a keen sense of the sound bite. His austere intellect could burst without warning into flights of emotion.

He was a Jewish-Israeli nationalist to his fingertips, yet unlike the rough-hewn farmer-soldiers who founded Israel, those fingertips were always manicured. He loved to kiss a lady's hand, and rarely appeared in public without a suit and tie.

He could be exasperating, especially when hectoring those who disagreed with him. He could be downright funny, even self-parody-

Emerging from the State Department one day, he spotted an Israeli reporter on his knees fiddling with his microphone. "On your feet!" he playfully upbraided the reporter. "A proud Jew does not bend his knee in the American State Department!"

When he slipped in his bathroom and broke his hip, a newspaper columnist accused him of covering up the gravity of the injury. From his hospital bed, Begin dictated a 2,500-word response, minutely detailing the mishap.

"I tried to get up. I couldn't. I groaned with pain. I tried to call my wife for help but she couldn't hear because the radio I had with me was playing too loudly.

She happened to come in to wash her hands. She opened the door and saw me lying on the floor. She asked: What happened to you? I replied: I fell. She said: So get up. I replied: "I can't."

# **Former Prime Minister** Menachem Begin buried Monday in Jerusalem

JERUSALEM - Former Prime Minister Menachem Begin was buried Monday after being carried to his grave on the Mount of Olives by aging comrades in arms from Israel's war for statehood.

Thousands of Israelis, some in tears, accompanied Begin's body to the cemetery in Arab east Jerusalem where he was laid to rest next to his beloved wife, Aliza.

Begin, who died Monday at age 78, was a giant of the Jewish state, but he wanted and got a people's funeral. There was no coffin. He was carried to the grave on a stretcher, wrapped in a prayer shawl.

With Begin's death, his friends finally began to explain the riddle of his 1983 resignation. They confirmed what most Israelis long suspected. He stepped down because he was depressed over his wife's death a year earlier and because of the rising Israeli death toll in the Lebanon

The complexities of the Arab-Israeli conflict lent symbolism to Begin's funeral.

The Jewish cemetery on the Mount of Olives predates the conflict, but the area is in the part of Jerusalem that Israel captured in the 1967 Middle East war and annexed. Begin's burial there can only stiffen Jewish resolve to hold on to the

His son Benjamin, a 48-year-old member of Parliament who is considered a possible future prime minister, recited the Jewish prayer for the dead. He wore an open-necked shirt with collar ripped in a traditional mourning gesture.

Begin's three children spent most of the past six days by his hospital bed in Tel Aviv. He had been on life-support machinery since suffering a beart attack last week.

Prime Minister Yitzhak Shamir watched silently as sacks of soil were dumped in the grave and a plain marker with Begin's name was stuck in the earth.

The diplomatic corps was not invited, and the speedy burial left no time for foreign dignitaries to arrive. But Egyptian Ambassador Mohammed Bassiouni attended privately, as a gesture to the man who made peace with his country in 1979, Israel army radio said.

Begin's body was brought to Jerusalem, then driven across the city through throngs of mourners.

The graveside enclosure was too small to accommodate the crowd, but after the VIPs left, others filed by the grave: young and old, men and women, all bundled against the evening chill.

Israel television and radio stations broadcast the ceremony live.

Begin was born Aug. 16, 1913, in the then-Polish city of Brest-Litovsk. He studied law and married Aliza Arnold in 1939.

His family was murdered by the Nazis, but he escaped, reached Palestine in 1942 and took over the Irgun. The Irgun's most famous operation was the 1946 bombing of the King David Hotel, then the British military headquarters, in which nearly 100 British, Jews and Arabs died.

# Secret Soviet atomic city will remain sealed

STAVANGER, Norway Atomic cities where the Soviet Union secretly housed thousands of nuclear scientists will remain closed to protect the world from their doomsday weapons, the mayor of one of the cities said Monday.

Our country, Russia, is trying to protect you the outside world from that technology," said Velory Takayev, mayor of Arzamas 16, a city of 80,000 people that appears on no map but is about 300 miles east of Moscow.

Arzamas, Takayev said, "will be a closed city for an indefinite time."

Western experts fear that Soviet scientists, losing their privileges and jobs, might sell their skills to Third World countries aspiring to membership in the nuclear club.

The cities where the scientists live a map." also have stockpiles of atomic war-

heads and other nuclear material.

There is extensive organized terrorism in the world. If they got our technology, it would be a cause trophe for the world," said Takayey

Takayev said Arzamas 16 was once the most secret of 10 cities the Soviets created in Russia as nuclear weapons production and development centers during the 1940s and

Andrei Sakharov, the late physicist and Nobel Peace Prize winner, worked for 18 years in Arzamaa 16 and was denied permission by the former Soviet government to travel partly because of the secrets he learned there.

Takayev said through an interpreter that his city, where the Soviet hydrogen bomb was developed, was built around a nuclear research center and was surrounded with such secrecy that it was not even on

# Isolating Asthma gene

LONDON - British researchers say they are close to identifying a gene that causes asthma, a discovery a U.S. expert says could be a key step toward developing new ways to treat the disorder.

Asthma, which affects about 1 in 20 people, causes air passageways to narrow during attacks. Medication is used to control the condition, but there is no cure.

Dr. William Cookson of Oxford University said Sunday his team has determined that the asthma gene is among a stretch of 100 genes on the 11th chromosome, Scientists have long suspected the gene they are looking for is one of thousands on the 11th chromosomal pair.

Dr. Allan Weinstein, a clinical professor of medicine at Georgetown University and consultunt to the allergy section of the U.S. sorts of possibilities to block the National Institute of Health, said, action of the gene."

'it's always been clear asthma tends to follow a hereditary basis, but it's also been clear that other factors such as the environment and or infectious diseases can influence the development of asthms.





He would lace his remarks with Yiddishisms. Gazing at the Pyramids from an aircraft, he wondered "how they ever schlepped those rocks up there." Forbidding an Israeli political rival to visit Morocco, he exclaimed contemptuously, "Morocco, Schmorocco!"

At the same time, the proud Israeli saw himself as a direct spiritual descendant of the ancient Hebrews. He celebrated his birthday only by the Jewish calendar, and when he came to office in 1977, aides were hard put to give his birth date by the Western calendar, or to say how he spelled his first name in English.

"Garibaldi was a lifelong republican, but he accepted a monarchy because it was the only way to unite his country," Begin explained.

This was the key to understanding Begin. In 1948, in a tearful radio broadcast, he told his extremist underground army to surrender its arms to the newborn state of Israel. Begin understood that the alternative was civil war.

Only an Israeli politician of towering stature and vision could have yielded the Sinai Desert in its entirety, as Begin did in 1979. Painful though it was to uproot Israeli settlements and surrender strategic real estate, peace with Egypt was a loftier goal, he said.

The peace treaty was sweet comfort after all the years of being called a hard-liner, an extremist and a ter-

Takayev, who came to western Norway to visit a group sending 40 tons of humanitarian aid to Arzamas 16, said, "Luckily, there is no mass exodus from these institutions," and added that no scientists assigned to any secret cities have left them yet.

"But we can say that if those living there have a big decline in their living standards, we can imagine that it would be natural for them to seek something better," Takayev

"If two, three or four really left and ended up somewhere, I don't think they could" develop a nuclear bomb for another country, he said.

"Each has an extremely narrow scope of knowledge and they would need a very large number of them to make a bomb.

"But if enough refugees ended up in the same place. They could develop a nuclear bomb. It would not be perfect but it would be good enough," he said.

Takayev said Russian President Boris Yeltsin visited his city Feb. 28, signing declarations that guaranteed housing and a good living standard for the scientists.

In the first step toward the implementation of free-market reforms, Russia since Jan. 2 has enacted a series of economic reforms that have created widespread hardships.

There have been reports some Third World countries are trying to coax Soviet scientists abroad with offers of salaries multiples higher than what they get at home.

Takayev said that when he started work at Arzamas 30 years ago, he signed a declaration promising that if ever left his job at the secret city, he would remain in Russia for a certain number of years. He said he was sure others had signed the same agreement and it would be difficult for them to get exit visas.

SGA CONSTITUTION

Daytona Beach Campus

PREAMBLE

The undergraduate students of Embry-Riddle Aeronautical catablish this University Constitution as a means to guide the Student Government Association (SGA) in its goal to promote the internal unity and welfare of the student community. Additionally, it provides a framework around which undergraduate students may respond to the challenges of a democratic society through the process of elective student government. Through this Constitution, the SGA strives to uphold fundamental human rights and individual responsibilities while recognizing and acknowledging the professional principles upon which this University was founded.

#### ARTICLEI RIGHTS AND FREEDOMS

The following rights and freedoms are inherent in the undergraduate students of Embry-Riddle Aeronattical University:

Section 1. All undergraduate students and recognized student organizations shall be entitled to all rights guaranteed to persons under the Constitution of the United States and its amendments therein, the State of Florida and Embry-Riddle Aeronautical University.

The right to fair and unbiased evaluation during and after completion of the course based solely upon academic performance which is to be defined by the professor of that class in the first meeting of the semester.

Section 4. In accordance with Aeronautical Embry-Riddle University policy and the Family Education Rights and Privacy Act (Section 513 of Public Law 93-380, Education Amendments of 1974) subsequent amendments, students have the right of access to their official records as described in the act. This includes the right of protection against any disclosure of information by the University concerning a student's views, beliefs, or political associations. The right to privacy with regard to a student's records shall be upheld, except by the student's own expressed permission, or under valid court order. Academic records may be referred to by appropriate University personnel.

ARTICLE II THE STUDENT GOVERNMENT ASSOCIATION

Section 1. Purpose: The purpose of the SGA shall be:

A. To strive to achieve the goals as outlined above in the Preamble.

B. To enhance undergraduate. student life at ERAU through the provision of services, events, and representation.

C. To provide a means for undergradest students to address issues administration.

Section 2. Organization: A. Branches: The SGA shall be composed of four branches. The first of these is the Executive Branch. Second is the Legislative branch, hereinafter called the

branch, hereinafter called the campus holding a minimum of six Student Court or The Court. Fourth is the Financial branch, tion for changes in either academic hereinafter called the Student Finance Board (SFB). The purpose of these branches is defined in Article IV Sections 1-4.

B. Divisions: The Divisions of the SGA shall consist of the Avion Entertainment Newspaper. Committee, and Phoenix Yearbook. Additional divisions may be added by Constitutional Amendment in accordance with Article VIII and Article IX. The purpose of each of these divisions is defined in Article IV Section 5.

C. The SGA Advisor and Secretary/Treasurer shall be ex-officio, non-voting members of the

ARTICLE III SGA MEMBERSHIP

Section 1, General Membership:

A. Any undergraduate student, as defined in the current University catalog, is eligible to be a member of the SGA.

Section 2. SGA Officials:

A, Officials of the SGA shall be: 1) SGA President

2) SGA Vice-President

3) Chief Justice

4) SRB Members

5) SFB Members

6) Avion Editor-in-Chief 7) Entertainment Committee Chairperson

8) Phoenix Yearbook Managing

9) Chairpersons of any future divisions (Chairpersons will not be officials of the SGA until the future division has been ratified).

B. Qualifications to be appointed or elected to an official position:

1) Must not be on disciplinary probation as defined in the current University catalog.

2) Must be at least a part-time student on the Daytona Beach (6) credit hours per semester. The und Secretary/Trensurer. Student Representative Board individual must also have been at .... A President

(6) credit hours for at least one (1) full semester prior to placement in office. For the purpose of meeting this qualification, summer terms A and B combined comprise one complete semester. However, a student must be enrolled for at least three (3) credit hours per summer term.

3) Must have at least a 2.5 cumulative grade point average (CGPA) as verified by the SGA Advisor.

4) Must attest, in writing, to the intent of remaining an undergraduate student, pursuing not less than six (6) semester hours of credit per semester on the Daytona Beach Campus throughout his/her term in office. Term encompasses approximately one year. For purposes of meeting this qualification summer terms A and B combined make one complete semester. However, a student must be enrolled for at least three (3) credit hours per term.

C. Qualifications to serve as an official of the SGA:

1) Must not be on disciplinary probation as defined in the current University catalog. Placement on disciplinary probation will result in immediate and automatic dismissal from the SGA.

2) Must be at least a part-time student on the Daytona Beach Campus holding a minimum of six (6) credit hours per semester. The individual must also have been at least a part-time student on this campus holding a minimum of six (6) credit hours for at least one (1) full semester prior to placement in office.

3) Must maintain at least a 2.25 cumulative grade point average (CGPA) as certified by the SGA Advisor.

ARTICLE IV SGA BRANCHES

Section 1. The Executive Branch: Purpose: To insure the overall mission of the SGA is carried out.

The Executive Branch shall con-Campus nolding a minimum of six sist of the President, Vice-President The President shall:

1) Bear ultimate responsibility for activities conducted by the SGA and its organizations within,

2) Shall coordinate and communicate with SGA Officials to further the interest of the undergraduate students at the University.

3) Have the responsibility to review all resolutions and SGA Formal Proposals made and passed by the SRB or SFB within seven (7) school days of the resolution. The President must exercise his authority to veto within seven (7) school days or the resolutions

and/or SGA Formal Proposals shall remain effective.

4) Publicly express the views and recommendations of the SGA.

5) Chair an SGA Executive Board Meeting at least once each semester for the purpose of coordinating the overall SGA function. This meeting shall include the Executive Branch, a tie. Chairpersons of Entertainment and the Student Representative Board, Chief Justice, Editor-in-Chief of the Avion, Managing Editor of the Phoenix and Chairpersons of any future division.

6) Hold an Open Student Forum twice per semester to inform the students of current campus issues and to receive student input and questions. This forum shall be scheduled at a time during the day when a majority of students are on campus. The format of a forum will be at the discretion of the SGA President.

Serve a term of approximately one year, to expire at the last SRB meeting of the Spring Semester and upon the installation of the newlyelected President.

8) Appoint students to serve on University Committees with the majority approval of the SRB.

9) Address the SGA at a monthly SGA meeting. This meeting shall be chaired by the SGA President, In addition to the Executive Branch, the Chief Justice, SRB Chairperson, and Division Chairpersons will attend. Division Chairpersons may designate another division member to attend if they are unable to. All members of SGA are encouraged to attend. A specific meeting day and time shall be determined and coordinated by the SGA President at a

time convenient for all SGA officials at the beginning of each

10) Have the authority to call any necessary joint sessions of the SRB,

SFB and Division officials. 11) Meet each month with the Vice-President of Student Life or his/her equivalent, to voice student

12) Act as primary representative at all community functions where the students' interests may lie; this authority may be delegated to other SGA members.

13) Serve as a voting member of the University Board of Trustees.

14) Have veto power over all leg-

B. The Vice-President

The Vice-President shall:

1. Be chairperson of the SFB and shall cast a vote only in the event of

2. Delegate duties and responsibilities to members of the SFB as necessary to conduct the business of the SFB.

3. Act as a liaison between the SFB and all branches and divisions of the SGA.

4. Serve a term of one year to expire at the last SRB meeting of the Spring Semester and upon installation of the newly-elected Vice President.

5. Attend all SRB Meetings, as an ex-officio non-voting member, and report on the SFB in SGA Monthly Meetings.

C. The Secretary/Treasurer The Secretary/Treasurer shall:

Be selected jointly by the SGA Advisor and the SGA President and shall hold this position until relieved by the SGA President and the SGA Advisor.

2. Perform the duties as directed by the current job description and title on file in The University department of Human Resources and the SGA, which shall be subject to amendment and/or approval by the SGA President and the SGA Advisor. The Secretary Treasurer shall also perform duties jointly assigned by the SGA President and SGA advisor.

2. Should the Vice-President vacate his office for any reason, a replacement candidate shall be elected by a majority secret ballot vote of a joint session of the SRB and SFB. These candidates shall be nominated from the current members of the SRB and SFB. Any member of the SRB and SFB may nominate himself/herself or some one else on the SRB or SFB Nominations must be seconded There then must be a 2/3 majority vote of a joint 2 session of the SRB and SFB to install the candidate-elect into office. The new Vice-President must immediately resign any other SGA offices currently held.

3. Should no official of SRB or SFB desire the position of Vice President, the President shall nominate a student at large for majority approval by a joint session of the SRB and SFB.

4. Should the President and Vice-President vacate their offices simultaneously for any reason, a new President shall be elected from the members of the SRB or SFB by a majority vote of a joint session of the SRB and SFB. The Vice-President's position shall then be filled according to Article IV, Section 1, Paragraph D-2.

Section 2. The Judicial Branch: Purpose: To protect the rights of

the student body and advise them of their responsibilities within the parameters of the University policies and procedures manual and to render interpretations of the SGA Constitution.

The Judicial Branch shall consist of the Student Court Chief Justice and seven Associate Justices, hereinafter known as the "Court."

A. Membership:

1) The Chief Justice, elected by the student body during the General SGA Elections.

2) Seven (7) individuals interviewed by the SGA President, Chief Justice, and SGA Vice-president. The majority vote by these three persons is required to place these justices into office.

3) Justices may have no affiliaentity during their term in office.

B. Meetings: Shall be chaired by the Chief Justice and must run according to the Student Court

Bylaws. C. Authority and Power: The judicial power shall extend to all cases arising under this Constitution, the Branches and Division Bylaws, guidelines and legislation enacted by the SGA; to all cases which may be referred to the Court by the Dean of Students Office, and disputes between students. The Court, also has the power to levy fines and recommend probation, suspension or dismissal: In addition, the Chief Justice shall swear in new SGA officials and Associate Justices.

D. Appeals: Decisions and recommendations of the Court shall be subject to appeal by the student through catablished University channels as outlined in the University student handbook.

E. Replacement of Justices: Should any Associate Justice position become open, the SGA President and Chief Justice shall interview and approve a qualified student to serve. The final decision of acceptance of Associate Justice applicants rests with the Chief Justice shall have. In the event of filling or replacing the Chief Justice, The Court will nominate candidates from among the Associate Justices to be interviewed and voted upon by the SGA President, SGA Vice President, and the SRB Chairperson. If no Associate Justices desire the post-

In all cases, the outgoing Chief Justice, and any Associate Justices may make their recommendations at any time during this process.

Section 3. The Legislative Branch:

Purpose: Be the policy and decision-making body within the SGA. Represent students interests and viewpoints as recognized by the SRB to the SGA President, University officials and campus

The Legislative Branch shall consist of the Student Representative Board, hereinafter known as the

A. Membership:

1) The SRB Chairperson, elected from and by the Representatives.

2) The SRB Representatives, elected by the student body in the SGA general election, or by the SRB when a position is unfilled or

3) Catalog Disciplines: SRB representatives are to represent the students enrolled in academic disciplines outlined by the University catalog at the Daytona Beach Campus. Each Representative shall be enrolled in the discipline he intends to represent at the time of election. Enrollment figures shall be taken from the Fall Semester preceding the general election. The number of Representatives for each discipline will be determined by the following:

1) Be the sole body within the SGA to initiate Formal SGA Proposals, A Formal SGA Proposal can include projects and resolutions. Each proposal will require sponsorship by at least one SRB Representative and must receive approval by majority vote of the

2) In conjunction with the SFB have the authority to override a Presidential veto on all Formal SGA Proposals concerning financial legislation. Such overrides require a cumulative 2/3 majority vote from the total membership of SRB and

3) Have authority to override all Presidential vetoes on non-financial legislation initiated by the SRB, with a 2/3 majority vote with the exception of approving new division Bylaws (see Article IX, Section

4) Provide for a compilation and publication of all legislation.

5) Approve an Elections Committee Chair and alternate to Board Meetings. conduct the SGA general elections according to the Election Guidelines

6) Establish its own meeting time and rules of procedure as dictated in the SRB Bylaws and assemble in open meetings, on a weekly basis, for the deliberation of legislation.

Section 4. The Financial Branch:

The Student Finance Board shall consist of six members and a Chairperson.

Membership: 1) The Chairperson shall be the SGA Vice-President.

2) Six individuals elected in the SGA general elections, or appointed to vacant positions by the SFB.

3) Members may have no affiliation with any other SGA Division or Branch during their term in office. The Vice-President shall, however, maintain his position on the Executive Branch.

4) The Secretary/Treasurer and SGA Advisor shall be ex-officio, nonvoting members.

B. Meetings: Establish its own meeting times and rules of procedure as dictated in the SFB Bylaws and assemble in open meetings on at least a bi-monthly basis for the deliberation of financial legislation. C. Powers, Duties and

Limitations: The SFB shall: 1) Oversee the budgetary process of the SGA as outlined in the SGA

Budget Guidelines. 2) Approve the SGA budgets as

whole, with a majority vote. 3) Have the responsibility to review and vote on formal SGA proposals insofar as it pertains to funding of the proposal.

4) Have the responsibility to review all Fraternity, Club and Organization (FC&O) Requests for Funds and to verify that funds would be used according to the FC&O Guidelines. The SFB shall have the authority to deny this funding if the requesting organization does not meet the FC& O guide-

5) In conjunction with the SRB, have the authority to override a Presidential veto on all Formal SGA Proposals concerning financial legislation. Such overrides require a cumulative 2/3 majority vote from the total membership of SRB and SFB.

6) Have sole authority to override a Presidential budgetary veto with a 3/4 majority vote.

7) Have the authority to select new members by majority vote when positions become vacant on the Student Finance Board.

Section 5. Divisions - AVION PHOENIX and ENTERTAIN-

Purpose: Each of these divisions exist to enhance student life at the University and are funded through and by the SGA.

The intent of these Bylaws is to provide clarification and details necessary for the execution of the SGA Constitution, and for such other legislation as may be included. No provision of these Bylaws, nor interpretations of them, nor subsequent amendments to them shall be construed or enacted to conflict with, abridge, or abrogate the SGA Constitution. Where such conflicts arise, the SGA Constitution or its interpretation by the Student Court shall prevail.

C. It shall be mandatory that all division Chairpersons or their designees as outlined in Article IV, Section (A-9) report in person at the regular SGA Monthly Meeting concerning the overall activities of the respective division. IMPEACHMENT

Section 1. An individual may be impeached for violation of the SGA Constitution, Division Bylaws, Budget Guidelines, or any other form of malfeasance as judged by the Student Court, Executive Branch, SRB, SFB or Division Chairs. Any member of the SGA may initiate impeachment proceedings upon any SGA Official by submitting a request for a hearing, in writing, to the Student Court Chief Justice. The specific charges causing the initiation of impeachment proceedings must be submitted to committees. This file shall be kept the Chief Justice, at least 10 days before the proceedings commence. All parties may present testimony, evidence, witnesses and character references to the Student Court at the time of the hearing. A 3/4 vote of the Student Court is necessary for impeachment and the Chief Justice may not vote. If the defendant is not satisfied with the Court's decision, he/she may file an appeal with the session of the SGA Executive Branch, SRB, SFB, Chief Justice and all Division Chairs, All parties, including the defendant, shall present their testimony, evidence, witnesses, and character references at this time. The SGA Advisor shall maintain order during the proceedings. A 3/4 secret ballot vote of the voting members present is necessary for impeachment. The votes Advisor.
